To Whom It May Concern:


We strongly protest the city's intention to board up the first story of the property at 676 Wells street and erect a fence around it.

We have been in the house and it is by all appearances livable and well maintained. It is unreasonable and bizarre to even consider tearing it down. It is also occupied, and has been during the three years we have lived at this address, by Arjo Adams, who is a responsible, courteous, and friendly neighbor who is well liked by the residents of our street.

Arjo removed a fallen tree limb from a power line in our backyard and helped us rebuild part of a fence that was knocked over in the same storm out of the goodness of his heart. He is a good man, a good neighbor and strengthens the community.
