**Description of Variance:**

**Locations:** Event will be located outdoors at Union Depot North Plaza

**Noise Source:** Twin Cities Jazz Festival has applied for a sound level variance, at a requested sound level limit of 90 dBA at 50 feet, in order to provide music outdoors at Union Depot North Plaza on Thursday, June 22 through Saturday, June 24, 2017, from 10:00 a.m. until 9:00 p.m., with a pre-event sound check at 11:00 a.m. on June 23, 2017 and June 24, 2017. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) the variance shall be for the hours of 10:00 a.m. until 9:00 p.m. June 22 through June 24, 2017. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured at 50 feet from the sound source from 10:00 a.m. until 5:00 p.m. on June 22 and June 23, 2017, and shall not exceed 90 dBA as measured 50 feet from the sound source on June 23, 2017 from 5:00 p.m. until 9:00 p.m. and June 24, 2017 from 10:00 a.m. until 9:00 p.m. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 9:00 p.m. on the dates of the event.
