Resolution to Recommend Adoption of the North End District 6 Plan as an Addendum to the  
Saint Paul Comprehensive Plan

WHEREAS, the *North End South Como District 6 Plan* was adopted by the City Council on April 18, 2012; and

WHEREAS, on January 1, 2014, District 6 boundary was changed (City Council Resolution 13-460); and

WHEREAS, District 6 amended its plan to be consistent with the new district council boundaries undertook general maintenance of its plan; and

WHEREAS, District 6 also integrated recommendations from the 2015 *District 6 Natural Resource Inventory Report* into the *North End District 6 Plan*; and

WHEREAS, the Saint Paul Planning Commission held a public hearing on the *North End District 6 Plan* on May 27, 2016; and

WHEREAS, the Neighborhood Planning Committee of the Saint Paul Planning Commission reviewed public testimony heard on the amendments to the *North End District 6 Plan*; and

WHEREAS, the Saint Paul Planning Commission is authorized under Minnesota Statutes Section 462.355(2) and Chapter 107 of the Saint Paul Administrative Code to recommend to the Mayor and City Council amendments to the comprehensive plan;

WHEREAS, the Saint Paul Planning Commission finds the amended *North End District 6 Plan* to be consistent with the Saint Paul Comprehensive Plan;

NOW, THEREFORE, BE IT RESOLVED that the Saint Paul Planning Commission recommends the adoption of the amended *North End District 6 Plan* as an addendum to the Saint Paul Comprehensive Plan subject to review and approval by the Metropolitan Council.
