Location: Mears Park

Noise Source: Kala Vandanam, Suchitra Sairam, Director, has applied for a sound level variance, at a requested sound level of 80-85 dBA, at no specified distance, in order to provide music outdoors for a dance performance at Mears Park on Saturday, August 12, 2017, from 5:00 p.m. to 8:00 p.m., with a pre-event sound check at 4:00 p.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for amplified music for the hours from 5:00 p.m. until 8:00 p.m., with a pre-event sound check at 4:00 p.m. on Saturday, August 12, 2017. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event shall not exceed 85 dBA as measured at 50 feet from the sound source during the hours of 5:00 p.m. until 8:00 p.m., with a pre-event sound check at 4:00 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 8:00 p.m. on the event date.
