Re: Remove or Repair of the Structure at <u>674 MAGNOLIA AVENUE EAST</u>

Dear Interested Parties:

This is to confirm that at the Legislative Hearing on December 10, 2024, Legislative Hearing Officer Marcia Moermond will recommend that the City Council grant 180 days to rehab the **property pending submission and approval of**:

- 1. **evidence of financing sufficient to complete the rehabilitation.** Financing could be business or personal accounts, a line of credit, or construction loan. Other types of financing will be reviewed on a case-by-case basis;
- 2. signed documents indicating title won't transfer until rehab is complete;
- 3. **submit an affidavit indicating the finances will be dedicated to completing the project** and not diverted until a code compliance certificate is issued;
- 4. **submit work plan, sworn construction statement, or scope of work.** This should include **signed** subcontractor bids which address *all items* in the Code Compliance Inspection Report and a **schedule** for completion of the project; and



5. the property must be maintained.

This matter will go before the City Council at Council Public Hearing on Wednesday, January 22, 2025 at 3:30 pm. in room 300 City Hall. If you are contesting Ms. Moermond's recommendation, or have not completed the above item(s), you may:

- 1. appear in person (please arrive before 3:30 p.m. and check in with staff outside Council chambers); or
- 2. Should you wish to testify remotely (and not appear in person), you must register by no later than noon on Tuesday, January 21, 2025 to testify via phone here: https://www.stpaul.gov/department/city-council/city-council-public-hearing-live-testimony.
