On 07/22/2019 at 0351 hours, SQD on routine patrol observed a large number of individuals loitering at 2516 7th Street West (RAS Restaurant and Lounge) after business hours. SQD made contact with several employees who stated individuals remained in the area after bar close.

On 07/22/2019 at 0351 hours, SQD 116 (D. McDonald) while on routine patrol observed a large number of individuals loitering in the area of 2516 7th Street West (RAS RESTAURANT and LOUNGE).

I was west bound on 7th Street West and was approaching the intersection with Davern Street, and observed a large number of adult males and females (75+) in the parking lot of the business at 2516 7th Street West (RAS) and the BP Gas Station at 2526 7th Street West. I observed a large percentage of these individuals appeared to be intoxicated, ie: loud voices, arguing, and unsteady walking.

I asked dispatch to send additional officers to respond, so I could further investigate. It appeared most individuals were staying in the area, and not making attempts to leave. I asked one of the males who was standing behind the BP Gas Station, where he was coming from, and if he was at an after party, I observed the male laughed, and he said he had been at RAS Restaurant and Lounge.

SQD 121 (I. Rock) was the first assisting officer on scene and walked to the main side entrance to the business and found it locked. We then walked towards the rear of the address, where there is a large wooden deck, with another entrance to the business.

I observed tow adult males on the deck and asked if they were employees of the business, and bother men said yes.

I identified both men verbally. I observed their eyes were bloodshot and watery and smelled of alcoholic beverages.

The first male was identified as [REDACTED]. [REDACTED] told me he is the bartender of the business and he was working on 07/22/2019 in this capacity, along with another female bartender. [REDACTED] told me the female bartender left the business after 0200 hours.

[REDACTED] told me it is the South Sudanese Independence Day and a large group was at the business celebrating. [REDACTED] at one point estimated they had over 300 customers and then I asked if he what the capacity was and he then said 200 people. He did not seem sure of the exact number. DESTA told me he made the last call announcement at 0150 hours, and then stopped at 0210 hours.

[REDACTED] said the customers then left the address and they all went into minivans and went to an "after party". DESTA then said the back door was not secured, and around 0320 hours, the group came back and they all entered the business again and the group stayed inside. [REDACTED] also said they had a Sudanese NBA player who was at the business also.

I did not see any minivans or buses in the area, and it appeared most individuals arrived and left in motor vehicles.

I then identified [REDACTED]. [REDACTED] told me he is the DJ for the business and was working on 07/22/2019. TSEGAYE said he has been working at the business for the past 10-12 years. TSEGAYE seemed nervous and said all individuals left the business at close, and no one re-entered the business after close.

At this time, I made a formal request to both [REDACTED] and [REDACTED]. I wanted to see captured video footage from inside of the business from 0200 - 0400 hours on 07/22/2019. Both said they did not have access to the office and the owner was the one who could provide it. Both [REDACTED] and TSEGAYE said their phones were dead and unable to call the owner, and inform him of my request.

I then asked [REDACTED] if I could do a final walk through to the business, as it seemed there were still a number of motor vehicles in the parking lot. [REDACTED] said he did not have keys to the business, and when [REDACTED] and him, walked outside of the business, the door locks behind them for the night.

I informed SQD 100 (Sgt R. Aguirre) of this information and he responded to the scene.

I Sgt. Stanway from DSI received this report.

On 07/22/2019 at 0351 hours, Officer McDonald was on routine patrol when he observed a large number of individuals loitering in the area of 2516 7th Street West (RAS RESTAURANT and LOUNGE).

Officer McDonald was W/B on W. 7th Street approaching the intersection of Davern when he observed a large number of adult males and females (75+) in the parking lot of the business at 2516 W. 7th Street (RAS) and also the BP Gas Station across the street at 2526 W. 7th Street. Officer McDonald observed a large percentage of these individuals appeared to be intoxicated, i.e. loud voices, arguing, and unsteady walking.

It appeared most of the individuals were staying in the area, and not making attempts to leave. Officer McDonald asked one of the males who was standing behind the BP Gas Station, where he was coming from, and if he was at an after party. This male laughed, and said he had been at RAS Restaurant and Lounge.

Assisting officers responded and they walked to the main side entrance of RAS and found it locked. Officers then walked towards the rear of the address, where there was a large wooden deck, with another entrance to the business.

Officer McDonald observed two adult males on the deck and asked if they were employees of the business, both men said yes.

Officer McDonald identified both men verbally. Officer McDonald noticed that both mens eyes were bloodshot and watery and smelled of alcoholic beverages.

The first male was identified as [REDACTED]. [REDACTED] told Officer McDonald he was the bartender of RAS and he was working on 07/22/2019 in this capacity, along with another female bartender. [REDACTED] told Officer McDonald the female bartender left the business after 0200 hours.

[REDACTED] told Officer McDonald it was the South Sudanese Independence Day and a large group was at RAS celebrating. [REDACTED] estimated they had over 300 customers. Officer McDonald asked DESTA what the capacity of the building was and he stated 200 people. [REDACTED] did not seem sure of the exact number. [REDACTED] told Officer McDonald he made the last call announcement at 0150 hours, and then stopped at 0210 hours.

[REDACTED] said the customers then left the address and they all went into mini vans and went to an "after party". [REDACTED] told Officer McDonald the back door of RAS was not secured, and around 0320 hours, the group came back and they all entered the business again and the group stayed inside. [REDACTED] also said they had a Sudanese NBA player who was at the business also.

Both [REDACTED] and [REDACTED] said their phones were dead and were unable to call the owner for assistance.

Officer McDonald asked [REDACTED] if he could do a final walk through of the business, as it seemed there were still a number of motor vehicles in the parking lot. [REDACTED] told Officer McDonald he did not have keys to the business, and when [REDACTED] and him, walked outside of the business, the door locks behind them.

RAS has conditions on their license.

Condition # 2 stated there shall be an employee on staff at all times with the ability to make video immediately available to SPPD and or DSI upon request.

Neither [REDACTED] nor [REDACTED] were able to do this when Officer McDonald asked for it.

This is a violation of condition #2.

It was also unknown if they had security that night and what time the required security left for the evening.

This report was forwarded to DSI for consideration on adverse license action.

Male was assaulted and medics were also called.

All involved parties uncooperative and no arrest were made.

On 7/9/2015 at approx 0128 hours, sq 121, Learmont and Carter responded to a call for an assault at the Ras Bar and Lounge.

The suspect left and the victim was still at the bar. Caller was uncooperative with the dispatch, stating that medics were needed.

When we arrived the medics were standing nearby, not wanting to enter the bar for an assault victim. A female that refused to cooperate and/or identify herself only summoned us in and asked where the medics were at.

A male, later identified as [REDACTED] was in the corner of the bar with another male, who also refused to cooperate. That male was holding a towel to Abebe's head. There was blood on the floor and on Abebe as well as the other male.

Medics were cleared in and walked Abebe out to their awaiting medic rig.

All the other unidentified males followed [REDACTED] to the ambulance and they were speaking an unknown language. They were told to leave the area once it became obvious that they were trying to argue with [REDACTED]. They were speaking English until [REDACTED] was asked if he knew who assaulted him. [REDACTED] said yes, and then the other males began to raise their voices and said "no" "no".

Medics transported Abebe to Regions with 126 T Yang responded taking photos and getting a medical release.

We returned to the inside of the bar to retrieve video from the apparent cameras that were in place, but the female bartender changed her story several times, telling us there were no cameras, then she didn't know how to get the video and finally saying that the video was only able to be viewed by the owner who was not present.

On 7-9-15, I reviewed a report written by Sqd 121 (LEARMONT/CARTER) regarding an Assault that occurred at Ras Restaurant, 2516 7th St W. I noted that responding officers had spoken with a female bartender at the scene regarding reviewing surveillance video from the business. The officers observed cameras in place and inquired. The officers noted in their report that the bartender had initially indicated to them that there were no surveillance cameras at the location to have captured the Assault. Officers noted that she later indicated that she did not know how to access the video and that the owner was the only person able to retrieve the footage. As a result, Officers were unable to view the video at the scene and turn it in as possible evidence of a crime.

I am familiar with this property from working on it as a Force Problem Property and monitoring it for Excessive Consumption of Police Services. I also am familiar with The Conditional Use Requirements of the business:

#1) states, "the licensee shall provide and maintain working video surveillance cameras on the premises (both inside and outside) in accordance with Saint Paul Police Department (SPPD) recommendations. The number of cameras, their placement and their quality must be approved by SPPD; and there shall be adequate lighting to support the camera placement. This equipment must be in operation during all business hours. Tapes/recordings must be maintained for a minimum of (30) days, and there shall be an employee on-staff at all times with the ability to make them immediately available to the SPPD and/or the Department of Safety & Inspections upon request.

I reviewed the property tax information and later contacted the owner listed (GERALD M MUNZEN) via telephone ph:651-278-0383. I spoke with a male who identified himself as: (BEDASSO, DEREJE DOB/10-21-64). BEDASSO stated he owned the business but his wife was listed on the license. I explained the circumstances of the incident and the importance of having video available to officers for the purpose of a Criminal Investigation. BEDASSO acknowledged that he knew having a video available to the Police upon demand was a condition of the license and apologized. BEDASSO said he is updating the camera system and that the employees will be talked to about providing video to police in the future. BEDASSO advised he wants to cooperate. I then asked BEDASSO if video was available of the incident on 7-10-15, and he said, "yes". He agreed to have 2 copies of the video copied onto a disc and turned over to police.

Officer CRAAG later responded and retrieved the video and turned it over to me.

I met with Sgt Tom Arnold of the Robbery/Homicide Unit, who is currently assigned to the case. I reviewed the video of the incident with him. The video was of very poor quality and it would be extremely difficult to identify a suspect. I turned the video over to Sgt Arnold. See his report.

I later turned a second copy of the video over to DSI Inspector Kris Schweinler for review.

There is no further information at this time.
