TO MEET THE CITY REQUIREMENTS, THE HOMEOWNER WILL NEED TO PAY FOR FULL FRAME REMOVAL, RE-ROUT THE OUTLET WIRES BY A LICENSED ELECTRICIAN, REBUILD THE EXTERIOR SIDING & BRICKMOULD, AND REBUILD AND STAIN/POLYURETHANE THE NEW INTERIOR WOODWORK. TOTAL COST TO HOMEOWNER WILL BE \$1.045, ABOVE THE STANDARD WINDOW COST.

You must attach a copy of the original orders and any other correspondence relative to this appeal.
