Location: Event will be located outdoors at Wild Tymes, 33 7th Place West

Noise Source: Wild Tymes has applied for a sound level variance, at no specified sound level limit in order to provide outdoor music at Wild Tymes Patio, 33 7th Place West on Saturday, August 13, 2016 from 1:00 p.m. to 8:00 p.m., with a pre-event sound check at 12:00 p.m. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance shall be for the hours of 1:00 p.m. to 8:00 p.m., with a pre-event sound check at 12:00 p.m. for a live band outdoors on Saturday, August 13, 2016. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source used for amplified music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 8:00 p.m. on Saturday, August 13, 2016. A public hearing before the City Council on this variance request will be held on:

If you attend the public hearing, you will be given the opportunity to present verbal comments or objections before the City Council.
