THIS INDENTURE, Made this 15 day of June, 1966, between the City of Saint Paul, a municipal corporation under the laws of the State of Minnesota, party of the first part, and Port Authority of the City of Saint Paul, a corporation under the laws of the State of Minnesota, party of the second part,

WITNESSETH, That the said party of the first part, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, to it in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does hereby Grant, Bargain, Quitclaim, and Convey unto the said party of the second part, its successors and assigns, Forever, all the tract or parcel of land lying and being in the County of Ramsey and State of Minnesota, described as follows, to-wit:

Subject to temporary permit, dated December 17, 1965, to construct bridge in the vicinity of Minnetonka Street and the Mississippi River as granted by the City of St. Paul to the State of Minnesota; a tract of land being parts of Blocks 18, 19, and 20, Town of Brooklynd, with accretions and increments accruing thereto, bounded on the northeast by the northeast line of Chester Street vacated and the northwesterly extension thereof; on the northwest by the Mississippi River; and on the southwest and southeast by a line described as follows: Commencing at the northeast corner of the intersection of Chester Street and Alabama Street; thence northwesterly on a straight line along the northeasterly line of Chester Street a distance of 230.97 feet to a point, said point being the point of beginning of the line to be described; thence on a straight line at an angle to the left of 88°30' a distance of 91.19 feet to a point; thence on a straight line at an angle to the right of 15°31' a distance


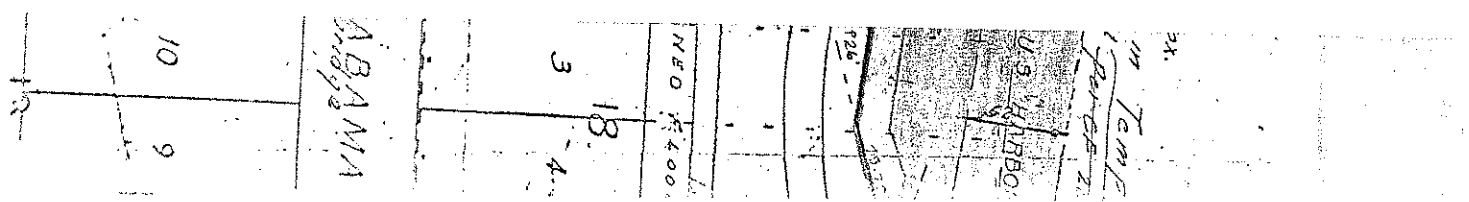

TO HAVE AND TO HOLD THE SAME, Together with all the hereditaments and appurtenances thereunto belonging or in anywise appertaining, to the said party of the second part, its successors and assigns Forever.
