Hi Stephanie

I just heard back from WM and I now understand the billing. The reason why you were charged a higher rate on the Quarter 1 2025 bill is because WM picked up four bags on October 3, 2024. This increased your bill just enough that it appeared you were incorrectly charged for a 96 gallon cart, but you were really charged for a 64 gallon cart plus extra bags.

I hoped this information helped cleared things up. The charges are valid. You can still attend the legislative hearing, but you would be disputing the extra bags fees instead of being incorrectly billed for the wrong size cart. Extra bags fees are typically not usually disputed a legislative hearing, but it's up to you. Extra bags are \$3 plus taxes and fees.

You can pay your garbage assessment online using the Assessment Payment Portal at stpaul.gov/assessments with a check, debit, or credit card, or you can mail a check (written out to CITY OF ST PAUL - ASSESSMENTS) and send it to:

I understand your concerns and frustration. The bags were collected on October 3, 2024 and you requested the larger cart on January 27. If the cart exchange happened as planned, you would have still been charged for the extra bags, and the larger cart on the Quarter 1 2025 billing statement.

You could contest the extra bag fees at the legislative hearing on July 10 but contesting the bag fees does not always mean the bag charges will be removed.

PO originally called in to ask about how a legislative hearing was scheduled and how to resolve billing and cancel the hearing. Informed PO of legislative hearing process. PO then requested larger cart, and when I informed her that she has the largest cart available, PO stated she has the medium and sent a photo to confirm size. PO's Q1 2025 bill should reflect billing for 1 64 gallon cart from April 1, 2025 - June 26, 2025.

However, WM informed me that she has always had a 64 gal cart, and the extra charges are for bags. PO is now requesting hearing to dispute bag charges and asked us to swap 64 to 96 gal cart

Bags are \$4.19 after CEC and SWMT fee. PO had 4 bags on October 3, 2024
