NOTICE OF VIOLATION AND REQUEST FOR REVOCATION OF LICENSE

Peters Market Inc. d/b/a Peters Market 530 Saint Peter Street Saint Paul, MN 55102

RE: Cigarette/Tobacco license held by Peters Market Inc., d/b/a Peters Market, for the premises located at 530 Saint Peter Street in Saint Paul. License ID #: 20200001649

Dear Licensee:

The Department of Safety and Inspections (the "Department") is recommending adverse action against the Cigarette/Tobacco license held by Peters Market Inc., d/b/a Peters Market (the "Licensee"), for the premises located at 530 Saint Peter Street in Saint Paul (the "Licensed Premises") for a second flavored tobacco violation.

Saint Paul Legislative Code section 324.07(j) prohibits a tobacco licensee from selling, offering for sale, or otherwise distributing any flavored tobacco products.

Saint Paul Legislative Code section 324.10(b)(2) sets the presumptive penalties for violations of provisions of the Legislative Code relating to the display, possession, or multiple incidents of sales of menthol or flavored tobacco products. Under section 324.10(b)(2), the presumptive penalty for a second violation within a 24-month period is revocation of the license.

Records from the Department show that on January 27, 2023, during a complaint inspection of the Licensed Premises, an inspector discovered prohibited flavored tobacco products in a metal drawer to the left side of the counter.

The Department asserts that the following facts, along with photos of the violations attached herein, constitute proof of a second violation of section 324.07(j) of the Saint Paul Legislative Code by preponderance of the evidence.

Synopsis of Alleged Facts:

Records from the Department show the following violations

On May 12, 2022, a Department inspector conducted an inspection of the Licensed Premises and found multiple flavored tobacco products. Based on these findings, the Department recommended adverse action against your Cigarette/Tobacco license and a 10-Day suspension of your license. The license was suspended from September 2, 2022, until September 11, 2022.

On January 27, 2023, Department Inspectors Joseph Voyda and Allan Vang went to the Licensed Premises to investigate a complaint related to the sale of prohibited flavored tobacco products. Inspector Vang entered the Licensed Premises and attempted to purchase a pack of Newport Menthol Cigarettes. The Clerk, whose name was Alex, told Vang that they do not sell any Newport Menthol Cigarettes.

Inspector Voyda then entered the store and informed the clerk that the Department received a complaint of the business selling flavored tobacco products. He asked the clerk to contact the license holder and informed him that they were there for a tobacco complaint inspection. Alex stated that the licensee was out of the country in Liberia. During the inspection, the inspectors observed and documented with a report and photographs, prohibited flavored tobacco products in a metal drawer on the left side of the counter and wall display case behind the counter. Specifically the metal drawer held 31 single packs of Newport Menthol Cigarettes, 1 carton of Newport Menthol Cigarettes (which contains 10 single packs), 1 pack of Alfakher (mint flavor), 4 packs of Natural American Spirit, 1 pack of Winner Menthol Cigarettes, 3 packs of Mlack & Mild Wine Cigars, 2 Black & Mild Wine Cigars in an open box, 1 pack of Twisted Palm Island Hopper, 1 Pack of Dutch OG Fusion, 1 pack of Dutch Leaf, 1 pack of Blow vape, 1 pack of Zig-Zag Hemp Wrap Blue Dream, 2 packs of Backwood 5 Honey Cigars, 1 GST Plus Lush Ice Vape, 1 pack of Backwood Honey Berry 5-cigars and 1 pack of Frontoleafmaster Palma Cigar Wrap.

Once Department Inspectors concluded their investigation, they advised the clerk to place all flavored products into a back storage room.

You have three (3) options to proceed:

1. If you do not contest the imposition of the proposed adverse action, you may do nothing. If I have not heard from you by **March 13, 2023**, I will presume that you have chosen not to contest the proposed adverse action and the matter will be placed on the City Council Consent Agenda for revocation of your license.

2. If you wish to admit the facts but you contest the revocation of your license, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing no later than **March 13, 2023**. The matter will then be scheduled before the City Council to determine whether to revoke the license. You will have an opportunity to appear before the Council and make a statement.

3. If you dispute the facts outlined above, you may request a hearing before an Administrative Law Judge (the "ALJ"). You will need to send me a letter disputing the facts and requesting an administrative hearing no later than **March 13, 2023**. At that hearing, both you and the City will appear and present witnesses and evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At the public hearing, the City Council will decide whether to adopt, modify, or reject the ALJ's report and recommendation.

<u>Please note: If you choose an administrative hearing, the Department reserves the right to</u> request that City Council impose the costs of the administrative hearing, per Saint Paul Legislative Code section 310.03(k).

If you have not contacted me by March 13, 2023, I will assume that you do not contest the Revocation of your license. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.



Details of Conversations (Statements to and by Person Responsible for Property):

Upon arrival I went into the store to attempt to purchase a pack of Newport Menthol cigarettes Clerk Alex stated they don't sell any Newport Menthol cigarette. Inspector Voyda entered the store and introduced ourselves as Licensing Inspector for the City of Saint Paul with Department of Safety & Inspections (DSI). Inspector Voyda explained to Alex that the reason for today's visit was due to a complaint received by DSI for allegedly selling flavor products. Inspector Voyda requested that Alex call the license holder to make him aware that we were here for a tobacco complaint inspection. With permission from Alex to go behind the counter to conduct an inspection. Alex stated that the licensee was out of country in Liberia. Upon our inspection we found flavor tobacco cigarettes and cigars in the metal drawers to the left side of the counter and couple on the wall display case on the back. Inspector Voyda advised Alex to place the flavored cigarettes and cigars in a bag, remove the flavored tobacco products and place them in a back room away from the front counter. Inspector Voyda was able to find a room in the back where Alex could place the tobacco products in. After the inspection Alex had stated to Inspector Voyda, "if we stop selling flavor tobaccos, our license will be good and not be taken away?" Inspector Voyda replied, that he didn't know the answer to that, until the the Adverse Actrion went through City Council. Located to the left side of the register counter there was a metal drawer that had thirty-one (31) single pack of Newport Menthol cigarette, one (1) carton of Newport Menthol cigarette which contain ten (10) pack of cigarette inside, one (1) pack of Alfakher (mint flavor), four (4) pack of Natural American Spirit, one (1) pack of Winner Menthol cigarette, three (3) pack of Black & Mild Wine cigar and two (2) Black & Mild Wine cigar in an open box, one (1) pack of Twisted Palm Island Hopper, one (1) pack of Dutch OG Fusion, one (1) pack of Dutch Leaf, one (1) pack of Blow vape, one (1) pack of Zig-Zag Hemp Wrap Blue Dream, two (2) pack of Backwood 5-Honey cigars, one (1)

GST Plus Lush Ice vape, one (1) pack of Backwood Honey Bourbon 5-cigars, one (1) pack of Backwood Banana 5-cigar, one (1) Cali 2K Mango vape, One (1) pack of Backwood Honey Berry 5-cigars, and one (1) pack of Frontoleafmaster Palma cigar wrap. (See Photo's for all flavor violations)
