			existing restrooms, again without any permits. I inspected the space on 2/11/04 and observed that the toilet rooms were essentially gutted. The concrete floor was open exposing the waste piping. See sketch in address file of existing floor layout, Per my conversation with Ed Locke, I have informed owner that he needs to remodel these restrooms to provide a male and female handicapped accessible facilities. As of 2/10/04, People Plumbing has applied for the plumbing permit but no building permit has been obtained. The owner was advised of the need for a general construction permit, as well as permits for plumbing, electrical and ventilation. (see letter in "Document")
