The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **June 20, 2024** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code¹ (see footnote 1, below).

1. SPLC 34.11. - **HEATING FACILITIES:** Every residential building or residential portion of a building shall have heating facilities that are properly installed, safely maintained and in good working condition, and capable of safely and adequately heating all habitable rooms, bathrooms and toilet rooms located therein to a temperature of at least sixty-eight (68) degrees Fahrenheit.

PLEASE PROVIDE AN APPROVED PERMANENT HEATING SYSTEM FOR THE SECOND FLOOR UNIT UNDER PERMIT. PERMANENET HEATING SOURCE IS REQUIRED FOR UNIT OCCUPANCY. IF HEAT IS NOT PROVIDED, THE UNIT MUST BE VACATED. THANK YOU.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will re-inspect these premises on **July 22**, **2024**, by which date the violations noted must be corrected. Failure to correct these deficiencies may result in an abatement and/or additional fees for re-inspection.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal and pay a filing fee.)
