Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting has been scheduled for **Wednesday, July 20, 2011 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse. Per our conversation, and with the agreement of the Department of Safety and Inspections, you will be representing the licensee at the public hearing due to the fact that he is out of the country at this time.

Enclosed are copies of the resolution and supporting documents which will be presented to the City Council for their consideration. This is an uncontested matter concerning the fact that on March 25, 2011, a clerk working at the Payne Ave's Shop-N-Go sold tobacco products to an under age person in violation of Minn. Stat. § 609.685 and Saint Paul Legislative Code 324.07 (c). This matter has been placed on the public hearing agenda portion of the City Council meeting during which public discussion is allowed. The licensing office will recommend a \$200.00 matrix penalty.


