Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting scheduled on **Wednesday, January 5, 2011 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

This is an uncontested matter concerning the fact that you were cited for several license condition violations during an inspection on October 26, 2010 and a re-inspection on November 8, 2010.
