Overview: Why are we here today?

Council, in alignment with the Administration, passed a resolution to ask the Charter Commission to amend the charter to include the Council's ability utilize administrative citations as a compliance tool.

With this Resolution, the Council is asking the Charter Commission to turn on the ability to add administrative citations to ordinances as a tool for consistent compliance.

What are administrative citations and how do they differ from current tools?

Administrative citations are a penalty for non-compliance rather than a fee for service. Example: The Fire Certificate of Occupancy reinspection fee is a fee for service, not a penalty fee for non-compliance.



Problem Statement

Problem

The City of Saint Paul's current tools to achieve compliance are not effective nor appropriate options for all situations.

Goals


- Compliance with the city's codes that is consistent and timely
- Emphasize education, escalate to penalties only when necessary
- Graduated, appropriate, and effective city response for every situation

Recommendation

Charter Commission to authorize City Council to include Administrative Citations as a step that can be used in some situations.



Current Tools for Compliance



Due process is *already* built into all compliance actions of the city.



Opportunities: Administrative Citations Could Used to Achieve Better Results

Department of Safety and Inspections (DSI)

- Animal Services - Unlicensed Animals, Dog Bites, Dog at Large
- Construction - Work without proper permits, Work without competency card, Safety violations, Failure to final permits
- Zoning - Compliance with Site Plans, Un-permitted Signs, Unapproved Land Uses, Lighting Violations
- Rent Stabilization- increasing rent above 3% without approval or meeting an exception
- Housing – long term non-compliance

Human Rights and Equal Economic Opportunity (HREEO)

- Earned Sick and Safe Ordinance
- Minimum Wage Ordinance
- Wage Theft Ordinance

Public Works Department (PW)

- Right of Way (ROW) permits (all areas)
- Sewer Utility permits
- Encroachment permits
- Illicit discharges to the storm or sanitary sewer systems
- Sidewalk permits
- Ordinance permits
- Unauthorized use of the ROW and other Public Works infrastructure

High Rise Non-Compliance

- Downtown commercial/residential building with local manager, investor-owner
 - Repeat attempts to gain compliance for maintenance items are unanswered
 - Filed criminal citation against local manager
 - Settled out of court with compliance path
- *Unused* alternative, disrupt several businesses and make 200+ families homeless
- Total duration: >3 years




Example: DSI

Dog Bite

Single mother trying to get her kids out the door and the dog escaped into the hallway

- Bit a person in the hallway
- Criminal citation issued
- Faced eviction because of the criminal charge
- Through ETHOS, expungement granted
- Being in court made her feel like a criminal
- If no expungement, an isolated incident would have led to many unrelated consequences
- ***She is one of 69 ETHOS participants in the last 4 years in this situation because of a dog bite.***



Criminal Citations





Example: DSI

Dog Bite

Resident's licensed dog bit a nearby park property user.

- Criminal citation issued
- Due to the confusing nature of the court system, owner fails to appear before the court for citation
- Warrant issued for arrest
- When the owner learned of the issue, they immediately appeared at Court offices to resolve
- Booked and spent more than 2 hours in jail
- Await their day in court, with the possibility of receiving a gross misdemeanor violation

Example: DSI

Criminal History

Resident loses bus driver job because of criminal record

- Finds out it is because of a citation issued by the City for not painting their house in a timely manner

Most people tell the City Attorney's Office that they are looking for expungement because of housing, education, or employment opportunities.






Example: DSI

Housing Non-Compliance

- Downtown high rise serving mainly residents earning below 50% AMI (known housing shortage for <50% AMI residents)
- Routine Fire Certificate of Occupancy inspection progressing then stalls out
 - Education, reinspections, mediation for months
- Owner essentially abandons responsibility for the building
- City joins the lender in court to have a receiver appointed
 - Likely would still have ended up in court but we could have gotten there sooner, resulting in;
 - Better outcome for residents
 - Better starting point for incoming receiver






Example: HREEO

Administrative Fines

- ✓ Minimum Wage First Violation: \$500 (payment to City)
- ✓ Possible Retaliation Under MW: 8 Employees x \$1,000 = \$8,000 (payment to Employees)
- ✓ Possible Retaliation Under MW: 8 Employees x \$1,000 = \$8,000 (payment to City)
- ✓ Lack of MW Notice & Posting: \$1,000 (payment to City)
- ✓ Insufficient Minimum Wage Records: \$1,000 (payment to City)

Total Admin Fines = Up to \$18,500



Example: HREEO

ESST Case, Homecare industry, complaint filed in July 2020, 114 employees, average hourly rate \$11.56. Total backpay owed \$32,942.15. Finally paid to employees Fall 2024.

Complainant stated they were not paid for time taken off to take care of a family member in December 2018.

- I always made up missed time because I needed the pay.
- I switched shifts to cover time, but I have never called in sick because there is no pay.
- I took unpaid leave for medical and childcare closure reasons.
- I did not know we were eligible to receive any paid sick leave and have gone into work when sick.
- I called in for time off but did not get paid.
- We do not get paid if we call in sick for work. I stopped asking because I knew we would not get paid.
- If I had paid sick time I would have used it. I requested time off and was allowed to take it unpaid.
- There is no vacation pay or sick leave. We were allowed to work and makeup hours.





Example: Public Works

Right of Way Car/Ped/Bike Access Violations

- **Now:** When a contractor does not comply with access requirements (for cars/peds/bikes), our only remedy is to place them on probation or issue a misdemeanor ticket.
 - This impacts their fees (2x) but not necessarily their subcontractors.
 - Compliance is delayed or ineffective.
- **With Admin Cites:** Fines would apply to anyone using the right of way (contractor or subcontractor).
 - Fine process would have to be established.
 - Compliance would be greater


Recommendation

Amend charter to allow the City Council to utilize administrative citations as a fair and effective tool to obtain compliance with city ordinances





Legislative Process and Timeline





Due Process – Some examples

- ✓ DSI -- Fire Certificate of Occupancy, Code Enforcement, Vacant Building orders go to the Council's Legislative Hearing Officer then to City Council.
 - Can be further appealed to the District Court of Appeals.
- ✓ DSI, PW, Water -- Property Assessments go to the Council's Legislative Hearing Officer then to City Council to be ratified before going to Ramsey County Property Records
- ✓ PED, DSI -- Zoning issues are appealable to the Planning Commission or Board of Zoning appeals before going to City Council.
 - Can be further appealed to the District Court of Appeals.
- ✓ DSI -- Business License adverse actions go to an Administrative Law Judge then to City Council.
 - Can be further appealed to the District Court of Appeals.
- ✓ DSI -- Building Code appeals go to the Building Official and can be further appealed to the MN Department of Labor and Industry.
- ✓ HREEO – Neutral fact-finding agency. After an investigation -- appeal to Department, City Council, and Court of Appeals


In all situations, you have a right to be heard, present evidence, be representative.

Council & Administration

- Propose changes to ordinances one at a time
 - Engagement on proposed ordinance change
 - Every ordinance change requires three readings including one public hearing
