Thank you for representing our district and for taking the time to read this letter. My name is Amy Alch and my family and I have lived in Highland for the last 21 years. I am very eager to see that our community does all that it can to reduce the harm caused by tobacco.

My mother smoked for 50 years and was lucky enough to survive a week in the ICU with pneumonia, emphysema and bronchitis. My cousin smoked for more than 50 years and had a lobe of her lung removed after a cancer diagnosis. I am just one person who life has been touched twice by tobacco and I don't even smoke.

They became addicted as juveniles and went down the road to their ill health and received thousands of dollars in health care. So many of those who start now may not have insurance one day, and we both know the cost to society for those who can't afford insurance.

Saint Paul was one of the first cities in the country to pass an ordinance that regulates the sale of flavored tobacco products. Thank you for taking these products out of stores where kids can enter and selling them only in adult-only tobacco shops.

Our city should treat menthol flavored tobacco products the same way that we treat the other flavored ones. Menthol is the most common tobacco starter for kids as the menthol flavor masks the harsh tobacco taste. For that reason alone, St. Paul needs to restrict access to all flavored tobacco products, and that includes menthol. We hope the St. Paul City Council will pass an ordinance to regulate where menthol tobacco products can be sold in order to protect our youth.

It is a rotten deal for the city of St. Paul to target menthol smokers and adults who use flavored tobacco. Either people are going to quit smoking altogether or they will travel outside the city to get their preferred brand. Either way, the city loses revenue. It seems strange to raise the taxes on smokers and then propose a ban that will force them to quit or buy from someone else. 
Dear Council Member Stark,

Our city officials should stop trying to interfere with the lives of tobacco users. The proposed ban on menthol cigarettes would be a major inconvenience for me and many others in the city. As someone who cares for an autistic adult child, I have quite a stressful life and find smoking to be a relaxing relief. The nearest place that I can purchase cigarettes is a mile away at a gas station. However, I prefer to go to a smoke shop that is over four miles away. This trip usually takes me over an hour because of the traffic. One of my friends who smokes menthols does not drive at all. Not being able to purchase cigarettes in Saint Paul would cause me to have to drive out of the city, and my friend would have to find a ride to purchase her cigarettes.

The city and state governments have already put too many restrictions on legal tobacco products. Taxes have gone up greatly over the past few years, making cigarette prices totally unreasonable. There have been times when I would use coupons for \$4 off at the gas station or \$1.25 off at the grocery store. Take into consideration the impact this ban will have on our businesses and citizens, and oppose additional tobacco flavor limitations.

It is not fair to single out certain smokers. Banning various tobacco flavors and menthol cigarettes will just be a big inconvenience that is not necessary. Because I am thirty-one years old and have long been considered a legal adult, I can make my own decisions without influence from the city council. This ban will also hurt our businesses.
