I live in St. Paul Ward 3 and am an educator and parent of two teenagers. I have known several people who have suffered from diseases relating to smoking and I am very eager to see that my community does all that it can to reduce the harm caused by tobacco.

Saint Paul was one of the first cities in the country to pass an ordinance that regulates the sale of flavored tobacco products. Thank you for taking these products out of stores where kids can enter and selling them only in adult-only tobacco shops.

Now comes the next step, to treat menthol tobacco products the same way that St. Paul treats the cotton candy and grape flavored ones. Menthol tobacco products, including chew and e-cigs, are uniquely attractive to youth because menthol makes it easier for kids to start using because of its numbing and cooling effect. Dear Council President Stark and Members of the Saint Paul City Council,  
My name is Dr. Sylvia Amos and I serve as President of the Women's Auxiliary of the Minnesota State Baptist Convention, Inc. The convention is comprised of 30 churches, nine of which are located in St. Paul. Our mission is to work with the youth and women of our convention churches.

I am writing to let you know that we support the proposed ordinance to restrict the sale of menthol tobacco to adult-only tobacco stores.

The Women's Auxiliary has been educating our young people about the harms of menthol for a couple of years. We have done informational sessions and presentations at basketball tournaments, youth choir meetings, youth group meetings, and the like. This is in addition to educating the various auxiliaries that are a part of the Minnesota State Baptist Convention.

Faith leaders, at all levels of the Minnesota State Baptist Convention, Inc., are supportive of restricting where menthol can be sold to prevent our children and grandchildren from suffering the same fate we have. Tobacco use is still the primary cause of preventable death and disease, claiming the lives of over 6,300 Minnesota adults annually and incurring \$3.2 billion annually in medical costs. Tobacco use is a major contributor to the three leading causes of death among African Americans—heart disease, cancer and stroke. According to the CDC, African Americans are more likely to die from smoking-related diseases than whites. My mother started smoking at the age of 11 and died of lung cancer at 71, a direct result of smoking menthol cigarettes for nearly 60 years!

Menthol is the number one tool that the tobacco industry uses to addict our young people. It helps the poison go down easier. The question is, do we give them the arsenic or do we take it away or do we make it harder for them to get? Making it easier and more accessible to obtain, in my opinion, is tantamount to assisted suicide. Yes, I know it is a legal, yet lethal, substance. Then I ask, is it legal to assist someone in killing themselves? Menthol tobacco products are a serious public health threat.

I urge you to pass this legislation, without delay. The health of our community is dependent upon all of us doing the right thing.

Dear Councilmember Tolbert: I am writing to you both as your constituent (492 Montrose Lane 55116) and as a longtime tobacco control researcher and advocate. I have spent my entire career (45 years in academia) working to help addicted smokers to overcome their addiction. I had the privilege of being a senior scientific editor of the landmark US Surgeon General's 1988 Report on Nicotine Addiction and was a member of the panel that produced the US tobacco dependence treatment guidelines. Currently I chair the committee that determines the venue for the triennial World Conferences on Tobacco OR Health. There is strong evidence that menthol facilitates youth starting to smoke and makes it harder for them to quit. We owe it to our youth to do what we can to protect them from initiating what all too often becomes a severe dependence resulting in serious illness and death. Internal tobacco industry documents reveal that the tobacco industry has a long history of using flavors to reduce the harshness of their products. Menthol is especially effective in this regard by cooling and numbing the throat. Currently, menthol is the only flavor still on the market.

Saint Paul has the authority to take effective action to restrict the sale of menthol tobacco to adult-only tobacco stores. With this ordinance you can help protect young people from what for many could become a lifetime of addiction.

I am writing to let you know that we support the proposed ordinance to restrict the sale of menthol tobacco to adult-only tobacco stores.

The Women's Auxiliary has been educating our young people about the harms of menthol for a couple of years. We have done informational sessions and presentations at basketball tournaments, youth choir meetings, youth group meetings, and the like. This is in addition to educating the various auxiliaries that are a part of the Minnesota State Baptist Convention.

Faith leaders, at all levels of the Minnesota State Baptist Convention, Inc., are supportive of restricting where menthol can be sold to prevent our children and grandchildren from suffering the same fate we have. Tobacco use is still the primary cause of preventable death and disease, claiming the lives of over 6,300 Minnesota adults annually and incurring \$3.2 billion annually in medical costs. Tobacco use is a major contributor to the three leading causes of death among African Americans—heart disease, cancer and stroke. According to the CDC, African Americans are more likely to die from smoking-related diseases than whites. My mother started smoking at the age of 11 and died of lung cancer at 71, a direct result of smoking menthol cigarettes for nearly 60 years!

Menthol is the number one tool that the tobacco industry uses to addict our young people. It helps the poison go down easier. The question is, do we give them the arsenic or do we take it away or do we make it harder for them to get? Making it easier and more accessible to obtain, in my opinion, is tantamount to assisted suicide. Yes, I know it is a legal, yet lethal, substance. Then I ask, is it legal to assist someone in killing themselves? Menthol tobacco products are a serious public health threat.

I urge you to pass this legislation, without delay. The health of our community is dependent upon all of us doing the right thing.

District 6 Planning Council met on September 5, 2017, and discussed the proposed amendments to chapter 324: banning menthol-type tobacco products from being sold in stores other than tobacco shops.

No one denies smoking negatively affects an individual's health and is a public health hazard. No one wants their children to smoke. We know that most people who become addicted to cigarettes begin smoking in their teenage years. We also know tobacco companies target marketing of menthol products to youth and communities of color.

## **Re: Menthol Cigarette and Mint and Wintergreen Tobacco Ordinance**

The retail trade associations that comprise the Coalition of Neighborhood Retailers and our respective retail store members located in St. Paul believe that it is vitally important to thoughtfully and thoroughly consider many questions that are raised by the proposed ordinance to prohibit the sale of menthol cigarettes plus mint and wintergreen tobacco products, except in tobacco-only shops.

The information provided to the St. Paul City Council by advocacy groups that are lobbying in favor of imposing restrictions on menthol cigarettes and mint and wintergreen tobacco products is insufficient to support adoption of these restrictions. The information is not sufficient because these advocates have failed to consider the following issues:

1. The impact of the proposed sales restrictions on neighborhoods and communities in St. Paul. For example, these impacts would include such matters as restricted access to food and grocery staples, retail employee job security, and crime related to an illegal underground market in restricted tobacco products.
2. The health impact of restricting the sale of mint and wintergreen smokeless tobacco and snus products.
3. The overall health impact on St. Paul residents because the proposed ordinance does not ban the possession or use of menthol cigarettes nor mint and wintergreen tobacco products.
4. The actual economic and health impact of the flavored tobacco ban enacted by the City of St. Paul in April of 2016.
5. The projected economic impact on St. Paul retailers that would no longer be



permitted to sell menthol cigarettes and mint and wintergreen tobacco products. The information provided to St. Paul City Council members by these advocates in a two-page document titled "The Potential Impact of a Menthol Restriction on Convenience Stores" is inaccurate and misleading regarding retail sales, retail profits, and market share of menthol, mint and wintergreen. There needs to be a reconciliation of the differences between the advocate's information and a new scientific economic impact study of restricting menthol, mint and wintergreen tobacco product sales in a major Twin cities municipality completed for the Coalition of Neighborhood Retailers by Management Science Associates.

6. The future impact on Minnesota's state budget regarding cigarette and tobacco excise tax revenue collections due to citywide menthol cigarette and mint and wintergreen tobacco product sales restrictions.

Given the importance of these issues and the need for accurate information on which to base such a significant policy decision, the Coalition of Neighborhood Retailers is requesting that the St. Paul City Council consider appointing a task force to research these issues and consider solutions based on verifiable and agreed upon information and data. This task force should include representatives of the city council, health related organizations, retailers, retail trade associations, consumers, and others including various experts whom could offer insight into the issue of menthol cigarettes and mint and wintergreen tobacco products.

We appreciate your consideration of our concerns and this request to appoint a task force to study the issue of menthol cigarettes and mint and wintergreen tobacco products.

I recently testified in support of a proposal to restrict menthol tobacco sales to adult-only stores in Minneapolis. St. Paul is now considering a similar proposal, and other cities are sure to follow.

When communities look to restrict menthol, one objection always comes up. The objection is, "Menthols are the cigarettes of Black people, so this proposal is racist."

You read that right. Here is a policy that will reduce smoking, save lives, improve health and protect pocketbooks in African American communities. And some people dare to say that's racist.

Who says this? Certainly the tobacco companies do. It's no mystery why. Menthols are some of the top-selling cigarettes in the country. I've heard them called the lifeline of the tobacco industry. When menthol restrictions come up, the tobacco companies are first in line to fight them. The reason is, they know a policy like this will work. It will keep tobacco away from kids in our communities, and make it easier for adults to make healthy choices. The harder they fight against it, the clearer that is.

But you may have heard others saying it. Before this issue came up in Minneapolis, I was listening to a show on the radio. The guests were introduced as "civil rights leaders" – which carries a lot of weight in the Black community. But they were spouting the same objections as Big Tobacco: menthol restrictions are racist, they're "a ban on Black smoking," they're another excuse for police to target Black men.

Well, a couple weeks later, the same show came clean: those "leaders" were in fact paid by R.J. Reynolds, maker of Newport menthol cigarettes, to spread misinformation. In fact, the menthol policy isn't a ban, there's no penalty on the buyer of the products, and there is absolutely no police enforcement component.

This is shocking, but also predictable. You see, it's part of a long game Big Tobacco's been playing, and Black people are the pawns. In the middle of the 20<sup>th</sup> Century, they decided menthol cigarettes would be "Black cigarettes." They put African Americans in ads, and placed those ads in Black neighborhoods and in Black magazines. The tobacco trials of the 1990s revealed how they researched us. Internal tobacco documents note that Black men associate menthol with "good taste, style and masculine strength" and how "impactful" and "effective" advertising to "Black young adult smokers" could make that preference even stronger.

I remember it happening. Even into the 1980s, they would hand out free menthols in our neighborhoods. Minty, clean-tasting . . . and easy to smoke. The cigarette companies were everybody's friend.

But when you think about it, it goes back even further – hundreds of years. It started when the first tobacco growers kidnapped Africans to pick the tobacco. Enslaved us, for tobacco. We're still enslaved to tobacco. No wonder the disease burden from smoking today is greater for us than for the rest of the population.

Regarding the proposal in St. Paul, I say it's about time. It's about time somebody asked, "Why is it 88 percent of Black smokers smoke menthols . . . compared to only 26 percent of white smokers?" It's about time somebody realizes that tobacco addiction is something the cigarette companies have done to us, done on purpose.

It's about time our elected leaders wake up to how the tobacco industry preys on our people – Black people. There's another famous quote from a Reynolds executive who said, "We reserve the right to smoke for the young, the poor, the Black and the stupid." That shows the contempt they have for us, and decent people everywhere should do whatever we can to stop them.
