As owner or person(s) responsible for : 1225 4TH ST E you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.

1. Remove improperly stored or accumulated refuse including: garbage, rubbish, loose and scattered litter, discarded furniture, appliances, vehicle parts, scrap wood and metal, recycling materials, household items, building materials or rubble, tires, brush, etc., from yard areas INCLUDING REMOVAL OF A DETACHED DOOR LEANING ON THE REAR FENCE, LOCATED NEAR THE ALLEY. Comply before October 26, 2016

If you do not correct the nuisance or file an appeal before **October 26, 2016** , the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.

**You must maintain the premises in a clean condition and provide proper and adequate refuse storage at all times

The telephone number is (651) 266- 8688. You must submit a copy of this Summary Abatement Notice with your appeal application.

***WARNING** Code inspection and enforcement trips cost the taxpayers money. Dear Mr. Willie Williams

I am the current owner and tenant of the property on 1225 4th ST E., St. Paul, MN 55106. I have received a letter in the mail pertaining to a SUMMARY ABATEMENT ORDER, #16-09619 dated Oct 19, 2016. The order is to eliminate detached door on fence in violation of chapter 45 of Saint Paul Legislative Code. This letter is very important to my family and me. We thank you for your continued efforts in regulating the city and being a neutralized disputer. I do not believe we are nasty dwellers compared to the other nuisance in my neighborhood. I believe there is a neighbor who is discriminating my family and I. We have never had anything kept on the property in violation of law, but this is the third order by the city of Saint Paul for corrective action to eliminate nuisance conditions.

I have placed the door on my fence on October 18, 2016 for anyone interested in recycling metal and within less than 24 hours, I am reported to the city. My property has been vandalized, cars broken into on five separate accounts and I believe the person who has continuously reported me to the city is the same person responsible in this discriminative vandalism of my property and vehicles. I ask the city to promptly look into this matter and to orchestrate a one on one meeting with the person who reported me to the city in this particular order as referenced above. I do not want this continuous allegation of my property to come about in the future and I require the city to disclose the nature of whom this person is who continues to harass and report my property to city.

I believe this is a discriminative act from within my neighborhood and to clear any misunderstanding and safety concerns amongst us neighbors, I am asking the city to disclose the source and to coordinate a one on one meeting with the source. This is a growing concern for my family and me. We feel discriminated and threatened.
