The Metropolitan Council, represented by Anne Taylor, Project Manager, who has been designated as the responsible person on the application, has applied for a variance to allow amplified music, announcements and speeches for the Green Line Opening Event (Raymond Avenue Station) to be held on the Light Rail Raymond Avenue Station at a parking lot near 2314 University Avenue. The variance is proposed for Saturday, June 14, 2014 from 9:00 a.m. to 4:00 p.m.

Noise Source: The Metropolitan Council has applied for a sound level variance for the Green Line Opening Event (Raymond Avenue Station), to allow amplified music, announcements and speeches between 9:00 AM and 4:00 PM on June 14, 2014 to be held at the Light Rail Raymond Avenue Station at a parking lot near 2314 University Avenue. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance will be for the hours from 9:00 AM through 4:00 PM on June 14, 2014 for the Green Line Opening Event (Raymond Avenue Station) to be held at a parking lot near 2314 University Avenue. 2) All electronically powered equipment used in conjunction with the event must not exceed 85 dBA, as measured at 50 feet from the sound source. 3) The applicant will provide personnel and equipment to ensure compliance with these conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices must be turned off no later than 4:00 p.m. on the event date.
