To Whom This May Concern;

I'm not sure where to begin... my mother passed away at the end of June with no will, its always understood that the house goes to the kids when our parents both pass. What had been decided on, or I should say considered by my sisters, at my mothers wake, that since my hubby and I have residing on the second floor for the past 15 years, that we should continue living there, since we'll need a place anyway. It seems evident that they have confidence in us, that we can. They proposed that we could pay the mortgage and Annette would pay for Excel, water, & trash. Based on experience, and history, the way she made sure that my mothers bills did not get paid, and deliberately made sure that Ma did not get mail regarding past-due & threatening to go into collections letters. This has been going on for years, my hubby and I have tried to inform the appropriate authorities to what we have discovered, in the way of potential, vulnerable & elderly abuse, extortion, neglect, psychological and emotional unsafe living conditions for my disabled brother and my elderly mother. My hubby and I were able to recognize tell-tale signs of aging. When the →

perpetrators of her abuse were respectfully confronted and advised that we have had concerns about my mother and politely explained those concerns to the victimizer's, it appeared to have worked against us, it basically assured them of their master plan. So in my hobby & my opinion, is that we couldn't count on Annette to take care of a house plant.

There was also mention of her daughter "Stephanie" living in the same house, which makes the words "Very Dangerous" the operative words when describing anything to do with; Stephanie, Rose, Annette, Mellisa and my sister Sandy, which is the group that puts a lot of effort and manipulation in deceiving county officials, law enforcement, support groups, churches, charities, while victimizing handicapped, disabled, and elderly along the way.

We've witnessed physical abuse to my nieces and nephews, and the sense of uncalled for hostile throwdowns, push, pull, even kick

-the kids when their on the ground, this done in front of other witnesses of this group, and when the appropriate authorities are informed of such an act on the child, the perpetrators seem to convince the authorities that the child is exaggerating and lying.

It appears, there seems to be a pattern here; "Who's the bully?"; How does one navigate through an overwhelmed system with limited resources? The system/county is really good at selling the idea that they heard us, understood our situation, and that we're 23<sup>rd</sup> on the list, that the above mentioned is true, and that the case will be filed. The person that interviewed us Officer Jeffrey \_\_\_\_\_ in "2013"

It makes one question; "Do they interview the elderly, vulnerable adult who's scared to tell the truth?"

It kind of puts out a picture that the victims, my mother a brother have the proverbial gun to their heads, stating to the interviewer, "We're safe, nothing wrong here", and the county considers that's good enough for them, case closed, not even a courtesy call to the advocates that put their necks on the line, for →

retribution, sacrificing what little safety my mom, my brother, and I had as it is.

We have concluded that these are the events that have unfolded; a constant bombardment of deceit, fraud, neglect, staggling, lying, theft & misdirecting in order to distort the truth from being discovered, and the truth of the matter is, when you cross the perpetrators, there will be hell to be paid. So, the worst has happened, my mother has passed, some real disgusting, distasteful things were done at my mom's wake and to my mother in her casket; right to her casket they continue to disrespect & violate her corpse. As we mourn and try to except passing, we realized theres alot that we have to do and take care of, like, making sure the mortgage is paid for, a strategy of how we will have to work with Annette. While doing so, we improvise by removing accumulated clutter, the type of clutter we call; "hoarding"

We consistantly committed so many hours every day not just because it had to be done, because history

Will repeat itself, and the malicious manipulators will use it as leverage, so the city can drop the hammer and assist the perpetrators in crushing the ones who desperately tried to become part of the solution, not the problem, and in doing so, they have achieved their objective. It appears we are being severely punished for protecting and defending my mother, my brother, fireman and ourselves. My hobby and I, know exactly what happened, how long its been happening, who the victims are, and who the perpetrators are. I'm sure people are going to say "It's a misunderstanding, that we're sorry about this, we're sorry about that." How is it someone can be sorry? Sorry that they didn't follow-up? Sorry they've been manipulated & scammed? Sorry they listened to a half a dozen manipulators? Instead of trying to assist two concerned family members in trying to prevent the outcome that we have to appeal today.

Being that this was written in advance, its to help put in perspective and reverse the decision on the house, so we can pick-up where we left off, like we were doing prior to the cities involvement.

I beg for mercy from the court that they see through this

situation and hopefully understand our dilemma.

We ~~recognize~~ realize theres going to be some significant transitions.

I plead the court that they let us back into our home so we can obtain the proper permits and address the corrections. We already had ideas about repairs and up-dating cosmetic-appearances this would need to be done if it were to go on the market. There doesn't seem to be any conflict of interest in doing so, no one else in the family has any interest or additional resources at this time to assist in this type of project. We would appreciate if we could at least have the option of doing so, we do understand that we may have to ~~pay~~ finance about \$10,000.00 of upgrades and hopefully this can all be just an embarrassing misunderstanding.

## Victims Statement

It would be hard to explain the events that unfolded because of the length & caliber of this tangled web. The reality is, that this should not have gone on for as long as it did. We carry enough guilt that we should have done more sooner, and then when one discovers the perpetrators do this on a daily basis and we stand back & do nothing about it, which is highly emotional & distressful, because we also have to consider who's business we're getting into. One has to fear eviction, assault or death, all in the name of safe living conditions for the elderly, handicapped and disabled.

What has effected me for years is constantly noticing the disregard of my mothers mental state and physical well being with certain individuals constantly threatening my mother in one way or another, be it to threaten suicide, or not letting her see her grandkids, or turn my mom in for things that are not in her control for reasons of retaliation. My hubby and I know this, because, mom approached us numerous times crying and frantic expressing her fears, and asking us, "What she should do?" Our response is, call the police,  
→

eventually she submits to the fear and in a sense, continues to pay out protection money enabling further extortion, this includes mental and emotional abuse to the parties that are truly concerned.

Today you can observe the stage prop that is never used until ~~today~~ ~~what~~ needed for manipulation in order to promote sympathy, and that she's the victim. Her daughter who stands before you is the one who makes calls to initiate chaos and physical harm to those who've been advised to correct certain issues on the home. We still have faith in the system and would not underestimate that they will be observing the body mechanics and the mental health of the alleged disabled. We have the utmost confidence that the educated and well advised will assist us in continuing a safe, civil, conclusion to this malicious, long lasting, mental, ~~psy~~ psychological, and emotional beating. This doesn't just effect where we live, this is effecting our future and his career.
