Dear Saint Paul City Council Members,

I am writing in application for the position of Interim City Councilmember for Ward 4. Regardless of whether I'm chosen for this interim position, I have zero intention to run in the upcoming Ward 4 special election. Furthermore, if I am appointed as interim City Councilmember I will refrain completely from publicly commenting on or endorsing any of the candidates running for election.

I have been a resident of Ward 4 since 2013, when I moved home to my native state after a decade on the east coast. I chose my neighborhood for its proximity to the soon-to-open Green Line light rail, and first became familiar with Union Park District Council during planning for the MLS soccer stadium a half mile from my house. As I've gotten more involved in local politics, I've come to appreciate the impact and meaning of people in the community taking action, investing time, and caring for their neighbors.

I see the Interim Ward 4 position an opportunity to step up and offer my time and experience in leadership, policy, and collaboration to the constituents of Ward 4.

Leadership: I'm willing to take the initiative to get things going and keep things running. I have chaired committees and task forces. I've organized and presented at numerous community meetings, including initiating regular meetings about soccer game-day transportation issues between neighborhood stakeholders, MNUFC and Allianz Field staff, Saint Paul Police Department, and city staff and elected officials.

Policy: In short, I'm kind of a geek about planning and policy in general, and the city of Saint Paul specifically. I'm interested in planning and zoning (the current book I'm reading is about zoning policy!) and have a favorite obscure city ordinance (did you know you're not allowed to shoot arrows in the street?).

I have corresponded and worked productively with city staff from a variety of departments, connected community members with information or contacts at the city, and become familiar with city ordinances, policies, and code enforcement.

My email inbox is full of updates from city subscription lists, and I regularly follow the actions taken by the Board of Zoning Appeals, Planning Commission, and Audit Committee. I have read many of the city's plans, including the Pedestrian, Bike, Climate Action and Resilience, and Transportation Safety Action plans, and reports including the Audit Committee's Constituent and Customer Services Report. I have attended community meetings for the city budget and followed the budget process.

Collaboration: I genuinely enjoy group projects and collaboration, and believe that putting in the effort to find common ground between different perspectives results in stronger work. I am currently working on the Snelling & University Alliance, a collaboration between Union Park

I have also worked on collaborative projects with representatives from other District Councils, including Saint Anthony Park Community Council, Highland District Council, and Macalester Groveland Community Council.

I have collaborated and and worked productively with people who don't all agree. As a stay-at-home-parent, I experienced dealing with stressful and quickly-changing situations and learning new skills on the fly. Now that my kids are school-aged and I am returning to full-time work, I have the time and energy to devote to serving Ward 4 until the special election this fall.

I'm qualified, ready, and able to take this opportunity to show up and do the work. Most of all, I truly LOVE the city of Saint Paul and believe in the ability of city government to effectively serve its residents. I would be honored to be appointed as interim Saint Paul City Councilmember for Ward 4.

Greetings! I am pleased to write a letter in support of Lisa Nelson's candidacy for the interim Ward 4 City Council position, pending an election in fall 2025.

I know Lisa through our collaborative work with Union Park District Council, where I was a board member from 2017 until 2024 and have served directly with Lisa on the UPDC Transportation Committee, which she co-chairs with both professionalism and heart. I also am managing editor at Streets.mn, where Lisa has contributed any number of thought-provoking, well-researched articles — including recently a series she co-authored on the city's Capital Improvement Budget (CIB) process and, significantly, ways to improve it. https://streets.mn/author/Inelson/

That last point — that she didn't just highlight problems but enumerated specific ways the CIB could be more equitable and engaging — speaks to who Lisa Nelson is. She is a doer. She gets her hands dirty (including with her organizing of weekly trash pickups for our committee at the University and Snelling intersection). She can both direct work and pitch in herself.

Perhaps my favorite example of Lisa's ethical, inclusive, community-minded spirit is through her efforts to convince the City of Saint Paul to adapt a Play Streets model of block-party organizing.

- An artist by practice, education and training, Lisa created a Play Streets website. https://stpaulplaystreets.wixsite.com/playstreets
- She advocated for policies that made it easier for neighbors to block off their streets and get together, allowing children to run more freely and adults to promote safety and community by getting to know one another.
- A model of calm, nonjudgmental leadership, Lisa did it all by learning about the current system, demonstrating respect for those who work within it and trying to convince people why there is a better way, one that serves renters as well as homeowners.

I can't speak to Lisa as a mother, a family member, a spouse or a daughter because I don't know her in that realm. But I do know that her family is essential and central to the work she does and the paintings she creates. And I know that the best story she crafted for Streets.mn was where she illuminated the sorrows and successes of her efforts to be a sustainably minded mother who goes car-free, hauling her children throughout the city on a cargo bike. https://streets.mn/2023/02/20/car-free-goals-how-to-succeed-through-failure/

Lisa operates without ego. She would seek to be a learner and collaborator within the City Council team, which has suffered stress in its loss of a transformative leader. Lisa is not political. But she is smart and strategic, hardworking and creative. She'd do well for my ward and for our city. I would be proud to have Lisa Nelson step, however briefly, into Mitra Jalali's shoes.

Dear Council members,

We moved into our house at the end of July of 2020. As you might imagine, that was not a great time for getting to know the neighbors. And, yet, I have a vivid memory of a family walking by —parents and two young children. Making sure to keep the standard (more than) six feet between us, we introduced ourselves to one another and we were welcomed to Herschel Street. Yes, that was the day I met Lisa Nelson, who I am honored to endorse as a candidate for the Interim Councilmember for Ward 4 today.

Since that day nearly five years ago, Lisa has worked tirelessly to secure the permits and promote the PlayStreets that have become the heartbeat of the vitality of our little neighborhood, tucked away between I-94 and University Avenue, in Ward 4. Starting with a Covid safe Halloween party, where the proper permits were secured so that the block could be barricaded and the kids could have some semblance of a "normal" Halloween, these block parties have become regular, much anticipated events on our block. Last spring, before the permits had been submitted, several children stood on the sidewalk in front of my house (where the barricades are stored) demanding "BLOCK PARTY! BLOCK PARTY!"

The children think that it is a normal thing to have twice weekly PlayStreet events where they ride their bikes, decorate both street and sidewalk with chalk, invent new games, and tie-dye Herschel Street shirts designed by Lisa and her kids. Our kids know each other, and we know them. The fact that my 9 year-old knows the adults on our block by name, and counts them among those who love and support her, is truly priceless. Lisa Nelson has spearheaded this effort and through her tireless support and quiet, behind-the-scenes work has led the way in creating the beautiful, life-giving neighborhood that I am so proud to call home.

Through her work with the Union Park District Council, particularly with the Transportation committee, Lisa has time and again demonstrated her capacity to research, learn, listen, and share information. Her article, *I-94 in the Union Park District: A History of Prioritizing Speed Over Community*, co-authored with Barb Thoman, is a demonstration of her depth of knowledge of the neighborhood and care for its residents, as well as her ability to collaborate with others. I have witnessed her use this historical insight as a way to build new pathways and imagine possibilities that build on the ever-important human connection that is, at the end of the day, the thing that is most important for the residents in our ward. I trust that when Lisa takes something on it will be done well.
