For

1As a resident of the Crocu Hill neighborhood, I am very grateful for the new organized Trash system. The neighborhood is now much cleaner, more quiet, and less Harmful to our roads and alleys.

2Pls be advised that I never received a garbage bin until 2 Oct2019 despite asking For a bin on three occsions--as follows:

13 May 2019 phoned Joe Kirby and requested a bin

20 May sent a letter to Waste Management in Phoenix Arizona (see attached)

24 July 2019 spoke to Joe Kirby again and requested a bin

19 Sept spoke to Alisha in customer service 651 266 5672 and requested help

She admitted that there are things that are "all screwed up" 26 Sept Chris Swanson called to discuss matter 651 266 8897 and requested a bin

1 Oct 19 a bin was delivered to my residence

I am age 77 and live alone in a two-condo converted duplex. I have a long history of Serious recycling and composting waste. As a result I have almost no garbage. What little garbage that I have disposed of (meat and chicken packaging) with The help of my brother in law in Fridley--whom I visit weekly.

Summary: I will be happy to begin paying a garbage collection fee now that I have a Garbage bin--beginning 1 Oct 2019. I consent to this as a community obligation. However, since Waste Management never provided me with any service prior to 1 Oct 2019, I have no financial obligation whatsoever to Waste Management--Because they never provided a service to me prior to Oct 2019.

First of all, let me express my appreciation that the city of St Paul has converted
To an "organized garbage pickup system". I have wanted such a system for
Years. Since your company became involved, there have been noteable
Decreases in large truck traffic and related noise and pollution
In our neighborhood. I wish the best for your company and hope that
It will flourish.

Re the present bill, your company has never provided me with a
Garbage bin--in spite of the fact that on 18 19 April, I left two
Messages with yhour employee "Angela" 888 960 0008
But received no call -back. I also spoke by phone with the city of
St paul liaison person named Joe Kirby 651 266 6103 on 13 May
Requesting a bin and explained the present problem--but have not received
Any report of any activiety on his part to date.

The point of this matter is this: your company could not have provided me with any
Garbage services to date ebcause you have never given me a bin.
I will be happy to begin payements as soon as you provide me with a bin.
As a a simple matter of commercial law, when no service or product is
Provided, no payment is due. You must therefore dismiss this bill
Because no services were provided to me during the time that is
Mentioned in the bill due to ~~to~~your administrative error.

Let me also state that I have been a fanatical recycler for most of my life.
I am a single, 76 year old male who wastes almost nothing--depending on
My compost heap and my recycling service for my garbage removal
Needs. However, I also realize that I have a civic duty to my community
To cooperate with your company . Therefore I look forward to receiving
A bin and my first real bill for actual services.
