Dear Mr. Hegna:

On August 30, 2010 you filed an appeal on behalf of 2446 University Avenue LLC of a decision by the Zoning Administrator. The Planning Commission denied your appeal and you filed an appeal of that decision to the City Council.

Minnesota law gives the City 60 days to complete its review of a zoning application but allows the City to "extend the time line ... by providing written notice of the extension to the applicant. The notification must state the reasons for the extension and its anticipated length, which may not exceed 60 days unless approved by the applicant." Minn. Stat. ' 15.99 (1995)

On September 16, 2010, you agreed to an extension to November 4, 2010.

This letter is to inform you that the City is extending the review period to December 28, 2010 (120 days from the date of the initial appeal).

The extension is needed so that the City Council can hold a public hearing on your appeal of the decision of the Planning Commission. This hearing is scheduled for November 17, 2010.
