I have been retained by John Davidson to appeal the Notice of Condemnation that he received on the above referenced property. Mr. Davidson had been staying elsewhere due to health issues, and had not been receiving his mail. When he did receive the Condemnation Notice he contacted our office. We are filing this as our appeal to your department's decision.

In review of the Condemnation Notice, it states that the principal violation is that the "water has been turned off due to a meter violation and lacks a basic facility." Mr. Davidson did pay the water bill. I have enclosed a copy of the invoice with a check attached. Our inquiry is regarding the latter portion of the violation "lacks a basic facility." Are there other violations that need to be corrected? After you receive this letter kindly give me a call so we can determine what the issue is.

## NOTICE OF CONDEMNATION AS UNFIT FOR HUMAN HABITATION AND ORDER TO VACATE

John R Davidson 499 Maryland Ave E St Paul MN 55130-3613

Dear Sir or Madam:

The Department of Safety and Inspections, Division of Code Enforcement, has determined that the dwelling and premises at **499 MARYLAND AVE E** is "Unfit for Human Habitation". In accordance with Saint Paul Legislative Code, Chapter 34, Section 23, the premises will be placarded on **3-14-11** and ordered vacated no later than **3-14-11**.

Your attention is called to the following provisions of Section 34.23, Subsection 6 entitled, "Vacation of Structure or Unit":

"Any residential structure or residential unit which has been condemned or placarded as unfit for human habitation shall be vacated within the time set forth in the placard and/or order. It shall be unlawful for any person to let to any person for human habitation any structure or unit so condemned or placarded, and no person shall occupy the structure or unit after the date set forth in the placard and/or notice."

THIS DWELLING SHALL NOT AGAIN BE USED FOR HUMAN HABITATION UNTIL WRITTEN APPROVAL IS SECURED FROM THE CITY OF SAINT PAUL; DEPARTMENT OF SAFETY AND INSPECTIONS, DIVISION OF CODE ENFORCEMENT

<u>Principle Violations</u>: These deficiencies must be corrected before this condemnation and vacate order will be removed.

1. The bldg constitutes material endangerment. The water has been turned off due to a meter violation and lacks a basic facility.

<u>Other Violations</u>: These deficiencies must be corrected in order to bring this property into compliance with the Saint Paul Legislative Code.

Authorization to reoccupy this/these dwelling unit(s) will not be given until it is demonstrated that all principal violations have been corrected and that no new conditions exist which could constitute material endangerment or which threaten the peace, health, safety or welfare of the occupants of this building.

All repairs and new installations must be made in accordance with the appropriate codes. Permit information may be obtained from the Building Inspection and Design Section, 375 Jackson Street, Suite 220, (651) 266-8989.

You may file an appeal to this notice by contacting the City Clerk's Office at (651) 266-8688. Any appeal must be made in writing within 10 days of the date of this notice.

It is the responsibility of the property owner to keep all buildings secured and to properly maintain the premises at all times.

If you have any questions concerning this matter, please contact the Inspector, Paula Seeley, at 651-266-1916. To arrange an appointment or request an extension of time to complete repairs, you will need to speak directly to the inspector.
