VI. TERM OF CONTRACT.

A. Effective date: October 12, 2015

- B. End date: November 24, 2015, or until all obligations set forth in this contract have been satisfactorily fulfilled, whichever occurs first.
- VII. <u>CANCELLATION</u>. This contract may be canceled by the Purchaser or the State at any time, with or without cause, upon three (3) days written notice to the other party. In the event of such a cancellation, the State shall be entitled to payment, determined on a pro rata basis, for work or Instruction/Activity/Service satisfactorily performed.
- VIII. <u>ASSIGNMENT</u>. Neither the Purchaser nor the State shall assign or transfer any rights or obligations under this contract without the prior written approval of the other party.
- IX. <u>LIABILITY</u>. Each party agrees that it will be responsible for its own acts and/or omissions in carrying out the terms of this Agreement and the results thereof to the extent authorized by law and shall not be responsible for the acts and/or omissions of the other party and the results thereof.
- X. <u>AMERICANS WITH DISABILITIES ACT (ADA) COMPLIANCE</u>. The Purchaser agrees that in fulfilling the duties of this contract, the Purchaser is responsible for complying with the applicable provisions of the Americans with Disabilities Act, 42 U.S.C. Section 12101, et seq. and regulations promulgated pursuant to it. The State IS NOT responsible for issues or challenges related to compliance with the ADA beyond its own routine use of facilities, services, or other areas covered by the ADA.
- XI. <u>AMENDMENTS</u>. Any amendments to this contract shall be in writing and shall be executed by the same parties who executed the original contract or their successors in office.
- XII. GOVERNMENT DATA PRACTICES. The Purchaser must comply with the Minnesota Government Data Practices Act, Minnesota Statutes Chapter 13, as it applies to all data provided by the State in accordance with this contract and as it applies to all data created, collected, received, stored, used, maintained or disseminated by the Purchaser in accordance with this contract. The civil remedies of Minnesota Statutes Section 13.08, apply to the release of the data referred to in this Article by either the Purchaser or the State.

In the event the Purchaser receives a request to release the data referred to in this Article, the Purchaser must immediately notify the State. The State will give the Purchaser instructions concerning this release of data to the requesting party before the data is released.
