Attachment to Summary Abatement Order

I, Parke M. Schilling, submit this attachment to my appeal of the summary abatement order. I have the following points to make:

- First of all, I question whether each item identified constitutes a nuisance under the Code.
- Second, I received an earlier notice and was given some time from the City's Inspection office to remove many of the items. I thank them for that. However, a number of factors have limited my ability to get this all cleaned up. First, I am a disabled veteran, and have health limitations as far as what I can lift, move or the like, and how much I can physically handle in a given day. Second, the difficult, and ongoing winter has limited what I can move, as many items were frozen in the ground. Basically, a week ago the snow went out and I was able to get many things out. Third, I am on disability and pension, but it is very small and I have little extra income to pay someone to get rid of the stuff, so it is on me. Given the above issues, I have done the best I can, and I need more time to get this done. As I said, I know I have had many weeks since the first notice, and I got a lot done, but with the ice and snow, not much more I could do.
- Attached are some photos of the progress I have made. I will continue to do what I can, as fast
 as I can, but I need more time. I have ongoing health issues that may require hospitalization,
 and I am requesting an additional 45 days to complete this cleanup.

Thank you for your consideration of my situation.

If you do not correct the nuisance or file an appeal before May 01, 2013, the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes. Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipment, etc. The rate will be approximately \$260.00 per hour plus expenses for abatement.
