Rehabilitate the house on the interior and exterior.

Details listed below:

Exterior:

- Replace fascia and soffits on the house (aluminum/steel)
- Install fascia on the garage wrap with aluminum
- Replace the driveway from the street to the concrete slab in front of garage
- Replace the 2 garage doors to the garage (no openers)
- Replace the service door to the garage
- Replace railing on front porch
- Build a deck on top of the front porch
- Replace both of the exterior doors (front and back of the house)

Interior:

- Demolition: As needed for project
- Replace plaster that is beyond repair with drywall (determined by contractor)
- Area where plaster was removed on exterior wall install vapor barriers and insulation
- Replace floor covering with carpet, vinyl, and laminate as discussed in person
- Resurface hardwood flooring as discussed in person
- Replace interior doors (swing and bifold)
- Replace trim work where necessary and reinstall existing trim where necessary
- Remove chimney in the house and patch/open where necessary

- Install popcorn texturing over ceilings where drywall installed
- Install one framing wall to divide main level bedroom
- Demolition all walls in the basement and paint floors gray and walls white
- Install proper gfcis where necessary
- Repair outlets to match code
- Install white outlets, switches, and covers
- Install smoke and carbon detectors
- Install drywall in the attic per existing framing
- Install proper insulation in the attic
- Paint the existing wood flooring in the attic

Bathrooms (2 each):

- Repaint existing bath tub if necessary
- Install plumbing for shower head spout
- Replace mixer
- Install new vanity, counter, sink, and mirror


