Location: Como Regional Park, Como Avenue East of Hamline Avenue near Fire Pit

Noise Source: All Community Events has requested a sound level variance to provide the use of a sound system for announcements and music at Como Regional Park, East of Hamline Avenue near the Fire Pit, for the Twin Cities Mother's Day 5K Run/Walk. The variance is requested at a sound level limit of 100 decibels (dBA), at no specified distance, for the hours of 7:00 a.m. to 11:00 a.m., with a pre-event sound check at 6:30 a.m., on Sunday, May 13, 2018. The Department of Safety and Inspections will be recommending the following conditions: 1) the Variance shall be for the hours of 7:00 a.m. to 11:00 a.m., with a pre-event sound check at 7:00 a.m., for the Twin Cities Mother's Day 5K Run/Walk on Sunday, May 13, 2018. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured 50 feet from any sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 11:00 a.m. on the date of the event.
