**NOTICE OF CONDEMNATION  
UNFIT FOR HUMAN HABITATION  
ORDER TO VACATE**

RE: 275 MCKNIGHT ROAD S

Dear Property Representative:

Your building was inspected on August 30, 2019.

The building was found to be unsafe, unfit for human habitation, a public nuisance, a hazard to the public welfare or otherwise dangerous to human life. A Condemnation Placard has been posted on the building.

The following deficiency list must be completed immediately.

**CONDEMNATION OF THE BUILDING REVOKES THE CERTIFICATE OF OCCUPANCY.**

Failure to complete the corrections may result in a criminal citation. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy.

**DEFICIENCY LIST**

1. THROUGHOUT - SPLC 34.23, MSFC 110.1 - This occupancy is condemned as unfit for human habitation. This occupancy must not be used until re-inspected and approved by this office.  
*-All tenant spaces at this property have been condemned due to a lack of basic facilities. The water service has been shut off to this building due to a private sewer line break.*

2. THROUGHOUT - SPLC 34.11 (4), 34.35 (1), MPC 708.1- Connect or cap the sewer piping in accordance with the plumbing code.  
***-Repair or replace the broken private sewer line. All work must be done by a qualified contractor and under permit. Tenant space 275 has a large access hole approx. 8 to 10 feet deep in the middle of the mercantile space with inadequate safeguards for the public.***
  
3. THROUGHOUT - SPLC 34.11(4), 34.35(1), MPC 601.1 - Provide an adequate water supply to all water closets, sinks, showers and tubs.  
***-The water service to the building has been shut-off. Restore the water service to the building.***

You have the right to appeal these orders to the Legislative Hearing Officer.
