Appeal of Ron Staeheli to a Correction Notice-Reinspection Complaint at 358 ARBOR STREET.

Legislative Hearing Officer Marcia Moermond distributed written notes. She said this was an appeal by the owner to be excluded from the Fire Certificate of Occupancy (FCO) program. The property came to the attention of the FCO program after a complaint of no heat in the lower unit on October 2, 2019. Heat was restored within three days; the inspector noted that eviction was filed on the tenant the following week. FCO staff sent a letter on November 19, 2019 indicating the property should be subject to a Certificate of Occupancy, because the department had come to the conclusion that it was not owner-occupied. Ms. Moermond reviewed the citation in Chapter 45 related to what is exempted from the FCO program, including owner-occupied single-family homes and duplexes if the property is the principal residence of the owner. She said there was a lot of conflicting information from City staff and the owner about the owner-occupancy status. Staff indicated that Ramsey County property records list the address of Diane Staeheli, who was reported to be the upper unit resident, as 4300 Blackhawk Road in Eagan which was also the mailing address in City records. The homestead for Ms. Staeheli was also in Eagan. Ms. Moermond read the definition of a homesteaded property in Minnesota which stated it was the owner's or a relative's primary place of residence. Ramsey County had reviewed and rejected an application from Ms. Staeheli to homestead this Arbor Street address. Ramsey County investigated and made a determination that it could not be a homesteaded property, and the application had been voided. This address was before the Council previously, and there was testimony from May 2018 indicating there was a renter in the garage, and that renter had made reference to both lower unit and upper unit tenants. US mail sent to Diane Staeheli at this address from the water department, FCO and Legislative Hearing staff had been returned. Ramsey County had looked at voting records as part of their investigation and found that Ms. Staeheli had been registered to vote in Eagan since 2002. She attempted to change her voting address to 358 Arbor in 2014 but this was declined as U.S. mail sent to confirm the address was returned to the elections office. Ms. Staeheli re-registered to vote in Eagan in 2016 and most recently voted there in November 2018. This was inconsistent with testimony provided by Mr. Ron Staeheli in a September 2018 hearing stating that Ms. Staeheli lived at the Arbor Street property. At the time of the no heat report in October 2019, the lower unit tenant clearly indicated to the inspector that the upper unit was not occupied by Diane Staeheli. The inspector noted that she crossed paths with a woman and child who stated they were visiting a relative in the upper unit and that relative was not Ms. Staeheli. Ms. Moermond stated that in Legislative Hearings the appellant submitted information indicating owner-occupancy, including old and current driver's licenses for Ms. Staeheli with the Arbor Street address, and an October 25 Xcel Energy bill directed to Ms. Staeheli at this address. Ms. Moermond said she didn't know if the bill was delivered to the Arbor Street address via U.S. mail or obtained online. She said Ms. Staeheli indicated in an email she was registered to vote from the Arbor Street address; Ms. Moermond was not clear if that registration had been changed since the most recent election. Both Mr. Staeheli and Ms. Staeheli testified in Legislative Hearings that Ms. Staeheli lived in the upper unit of the duplex. Ms. Moermond said taking the two sets of information together she did not believe this was the principal residence of Ms. Staeheli at this time. She recommended that the property be part of the FCO program as a non-owner-occupied property.

Councilmember Noecker confirmed with Ms. Moermond that what was before the Council was not consideration of any fine or penalty but that this was a non-owner-occupied property and therefore should have a FCO. Ms. Moermond said a non-owner-occupied property would require a FCO and periodic inspections.

In opposition:

Ron Staeheli said he didn't know about homestead application being voided. He said Diane (Ms. Staeheli) had put her maiden name on the mailbox and that was why mail was being sent back. He said Ms. Staeheli wasn't present was because she was ill. He said mention of a tenant upstairs didn't mean that Diane wasn't also there. He said he wasn't sure Vicki (downstairs tenant) said Diane didn't live upstairs; she may have said the landlord didn't live there. He said he was managing the property from his office at 4300 Blackhawk Road, and that's where they got all of their mail. They had lived together at 4300 Blackhawk Road for a time, but Ms. Staeheli had cancer in 2017 and moved in with the upstairs tenant who was serving as her caregiver. He said homestead status no longer saved a lot of money and was something they hadn't gotten around to. He was surprised and thankful to learn it hadn't gone through, so they were going to have to find out why. He said Diane absolutely lived at 358 Arbor; he had just left her there.

Tom Ellerman said he rented a garage space for storage and electrical work, and had been there a couple of years. He said the problem here was with the downstairs tenant making up stories. She was way off base and he'd had the police there a few times for things she'd done. He said he had seen Diane there many times. It had been difficult for the last year or so and he felt the downstairs tenant should perhaps be in an assisted care facility. She didn't get along with neighbors and called police on things like people blowing leaves into the street. He said he saw this as a vindictive attempt against Ron.

Bryce Staeheli (456 Osceola Avenue S.) said he lived at 358 Arbor Street for the first 19 years of his life. He said his grandparents lived on Palace and he lived on Osceola, all within a three-block radius of that. He said he did just leave the upstairs unit, and his mom was there now. He said the fact it had gotten to this point was ridiculous. He said Donald Trump's address was Mar-A-Lago, Florida, but he was in Washington, DC.

Councilmember Noecker moved to close the public hearing. Yeas - 7 Nays - 0

Councilmember Noecker said a FCO was a serious life-safety thing, and the City exempted owner-occupied properties because the assumption was the owner was there and making sure it was safe. She felt the key was not just residence but principle residence. She said the evidence was perhaps mixed on whether Ms. Staeheli resided at the property, but she felt it was clear it was not the principal residence. She said when testimonies were mixed, they should rely on the official reports from the County property tax records, U.S. mail, and Ramsey County elections, which seemed to be straightforward in showing there was a different principal residence. She said she would be happy to work with Mr. Staeheli and his family to clarify the issue, but for now would go with the Legislative Hearing Officer's recommendation.

Council President Brendmoen said she supported the motion, and appreciated the willingness to work with the family.
