Thank you Frances. **Please break down the total amount of credits that you will be adding to the account.**

Also, I understand that your recommendation to reduce the Q4 2021 assessment to \$69.04 is to account for the the cost of a 35-gal cart with every week service. **However, since they already made a payment of \$132.90, shouldn't the assessment be reduced to the difference between the payment and the actual cost of a 96-gal and a 35-gal cart (170.27)?** This would reduce the assessment to \$37.37.

As of that date, the property only had a 96 and 35-gal with weekly pick up. However the account was still being charged for a 96-gal cart and two 64-gal carts. **Please explain why this was the case and provide the following information for Q3 - Q1 2022:**

- Service Level (size and number of carts)
- Itemized breakdown of invoice
- Payment history
- History of Contact with property owner
