**Summary of Issue:** Could you break down this Q3 bill by item? Property owner stated that Pete's Rubbish missed his last pick up of on 07/02/2019. He stated that he called about the missed pick up a few days later and Pete's did not provide him with a reimbursement. He therefore calculated that the missed pick up was worth around \$4.25 and did not pay that amount of his Q3 bill (he only paid a total of \$66.09). However, the assessment that was sent to us doesn't seem to match up with a \$4.25 plus three additional late payments of \$3.04, which would add up to a total of \$13.37. Please respond as to how the \$9.10 was calculated.
