## A re-inspection will be made on May 3, 2011 at 11:00 am.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

YOU WILL BE RESPONSIBLE FOR NOTIFYING TENANTS IF ANY OF THE FOLLOWING LIST OF DEFICIENCIES ARE THEIR RESPONSIBILITY.

#### **DEFICIENCY LIST**

- 1. INTERIOR UNIT 12 SPLC 34.10 (7), 34.33 (6) Repair and maintain the ceiling in an approved manner.-Repair crack in kitchen ceiling in a professional manner.
- 2. INTERIOR UNIT 13 MSFC 1011.2 Remove the materials that cause an exit obstruction. Maintain a clear and unobstructed exitway.-Remove all items obstructing hallway to back door of Unit 13. Remove bed obstructing egress window in south bedroom of Unit 13.

- 3. INTERIOR UNIT 14 SPLC 34.12 (2), 34.35 (1) Repair and maintain all required and supplied equipment in an operative and safe condition.-Replace ceiling vent in bathroom in Unit 14.
- 4. INTERIOR UNIT 26, UNIT 32 SPLC 34.09 (3), 34.32 (3) Repair and maintain the window sashes.
- 5. INTERIOR MSFC 901.6 Have fire extinguishers recharged and tagged.
- 6. INTERIOR MSFC1026.1 Provide and maintain an approved escape window from each sleeping room. The minimum size must be 5 square feet of glazed area with a minimum of 24 inches of openable height and 20 inches of openable width. With a finished sill height not more than 48 inches. This work may require permit(s). Call DSI at (651)- 266-9090. Refer to the Escape Windows for Residential Occupanices handout for more information.-Upon inspection, double-hung windows in Unit 11, bedroom two of Unit 14, Unit 13, Unit 12, Unit 21, Unit 22, Unit 23, Unit 24, Unit 25, southwest bedroom of Unit 26, Unit 32, Unit 33, and Unit 34 measured 22 inches openable height x 28 inches openable width. South bedroom of Unit 14 measured 22 inches openable height x 32 inches openable width. Northwest bedroom of Unit 26 measured 22 inches openable height x 24.5 inches openable width.
