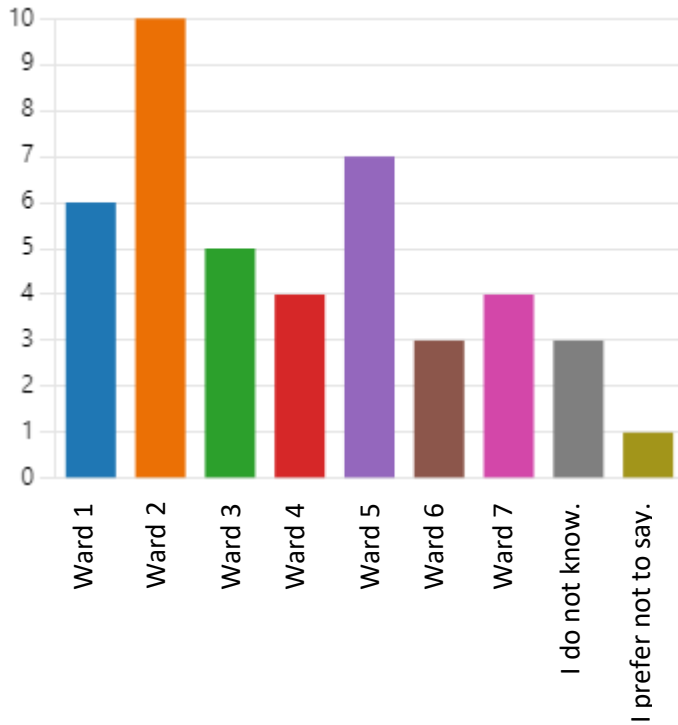


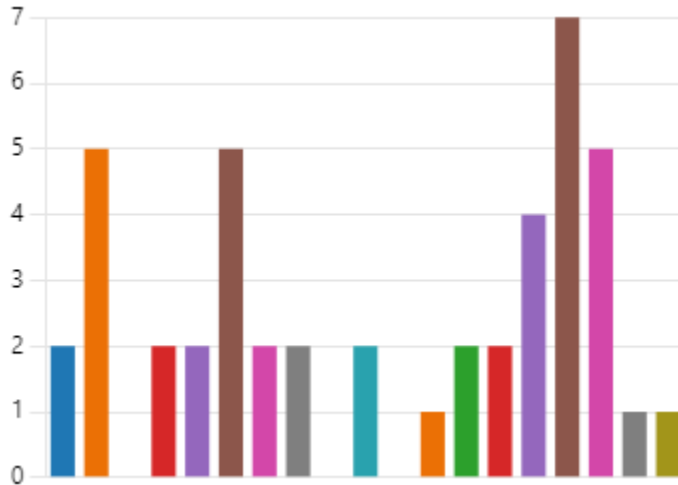

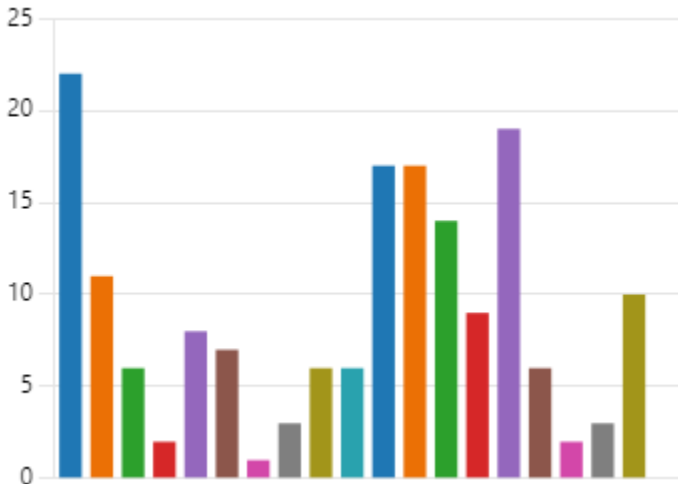

Neighborhood safety

Why are there no consequences for juvenile criminals in St. Paul? Totem Town was closed and nothing opened in its place. Juveniles taunt police and say they'll be out again to steal vehicles. This doesn't shock you? So taxpayers have to risk our safety, property and vehicles because these kids have zero consequences. Their parents want something done, they say they don't know what to do anymore. They're asking for help. Sheriff Fletcher has voiced options, but deaf ears from the city. Why do we pay taxes when this is one of the BIGGEST safety issues in our city and nobody is doing anything!? We lose good residents AND businesses every year because of the city's lack of action.

We understand that the closure of a transportation facility will have its consequences, affecting those who rely on it for their daily commutes. However, we strongly believe that the safety and security of our community members should take precedence over convenience. To mitigate the impact on commuters, we urge you to consider the following measures: 1. Alternative Transportation Arrangements: Explore options for providing alternative transportation methods to ensure that commuters are not unduly inconvenienced by the closure of the Union Depot platform. This may include increased bus routes, shuttle services, or improved connectivity to nearby transit stations. 2. Enhanced Security Measures: Allocate additional resources to bolster security in and around the Union Depot area. Increase the presence of law enforcement personnel, install surveillance cameras, and implement effective lighting systems to deter criminal activities and provide a safer environment for commuters and residents alike. Services have declined since this Mayor came into office. They only budget for a handful of snow emergencies....this is MN! It snows a LOT here and there were times when it snowed above the amount for a snow emergency and yet they did not plow. We sat with 12" of snow on our street for weeks wait8ng for it to melt because they decided not to plow. It's ridiculous!

Rumors over the past few years from someone that works closely and knows of some issues.

How much money is being spent on personal aids that are working for these departments. Why so much wasted tax payers money on special committees that aren't making a difference?

Crime is way up , roads are junk , taxes increased but nothing to show for it. I have 3 city lights burnt out for weeks now. My vehicle is being broken in to. Safety is 0

It would complete the flandrau bikeway in 1 block instead of having people travel up to Kennard

See the 2022-2023 data requests related to the "proposed" Summit Avenue bike trail that the City's planners seem to be actively and aggressively avoiding in order to push through a predetermined political agenda.

The streets are not regularly maintained, they are in terrible condition right now and snowplowing has been terrible for the past several years. Some say we don't have the right equipment. What needs to be done to get on track?

The potholes are terrible.

I feel that Saint Paul spends too much money on departments. This is reflected in the year over year percent increase in property taxes which is disproportionate to like sized cities elsewhere in the country.

Too many new initiatives and not enough creative use of existing resources and program

Pot holes in our streets are a danger to vehicles as well as pedestrians.

To build confidence in government systems it is necessary to have easily quantifiable metrics to judge performance. HR & EEO is an area that is historically based on personal judgement and tends to lack well defined performance metrics. The proposed audit would work to change that by showing the value it provides to residents.

I have lived in St Paul my entire life. I believe the Mayor is out of control on all the personal he has hired. It's more than any other Mayor.

Because we closed Totem town and the new place in Richfield never came to fruition...they need a place to be incarcerated for 6 months to stop all the horrible behavior.

Audit public works. - snow removal and road repair

I want to know there is consistency in who gets charged, for what, with what evidence, and who is offered plea deals based on what information.

Because we need help

Because without finding the answers to them, you will not make a positive deference and this city will soon become unlivable for me personally. I have lived here my whole live. 53 of my 62 years have been in the same home.

Everything that has been happening in the metro and beyond in recent years.

It's hard to fully the causes of justice system inequities when the data is so fragmented and much is missing or too aggregated to compare to other data.

The condition of the City's roads suggests a systemic problem in how the City has approached maintenance and rebuilding of the road network.

The City is increasingly pushing for very expensive bike facilities (raised separated trails) without showing that exceptionally higher cost is justified. The current bike plan (2015) lists the cost of bike lanes as 30,000 per mile and separated raised trails as 1,500,000 per mile. This is 50x difference (3:150). Standard bike lanes are more cost effective, allow more miles to be built out, appear to have similar safety outcomes. Moreover, by creating a larger network of bike facilities per dollar spent, they would appear to increase biking mode share by serving more communities. On-street lanes can also be plowed with the streets (e.g. for free) with some added supportive additional plowing for small snow falls. The additional plowing would result in a much lower cost overall than maintaining a fully separate system. The potential maintenance cost of plowing hundreds of miles of separated bike lanes (as suggested in the 2023 Draft Bike Plan) would be incredible expensive, and serve a very small portion of transportation needs, given that winter biking is <0.1% of transportation mode share.

The city infrastructure is a mess. Why is the city of Saint Paul so bad at plowing the streets in winter? The streets in West Saint Paul - Dakota County are plowed beautifully. How is the public works budget being spent? Does the money go to projects invented to hire friends and relatives? Where did all these massive bike trail plans come from? Minnesota is NOT a climate conducive to biking as transportation. Who is making money from bike trail construction? What happens to the big trees that are cut down? Are they sold? Are they disposed of?

Crime is rising and street/infrastructure are deteriorating

We have lost too many to Ash Borer. Do not put any more at risk.

St Paul is broken. Streets are a mess, public safety is deteriorated, and people are leaving the city

Excessive bureaucracy

Obvious reasons. Find a solution for these juvenile delinquents now.

I believe that the closure of the Union Depot platform should be explored because we as residents see it as a necessary step to ensure the safety and well-being of our community. I believe that by shutting down the platform, we can mitigate the risks associated with criminal activities and restore trust in local authorities and public spaces. While acknowledging the impact on commuters, we propose several measures to address the inconvenience: 1. Alternative Transportation Arrangements: Exploring options such as increased bus routes, shuttle services, or improved connectivity to nearby transit stations to minimize the inconvenience for commuters. 2. Enhanced Security Measures: Allocating additional resources to bolster security in and around the Union Depot area, including increased law enforcement presence, surveillance cameras, and effective lighting systems. 3. Community Engagement and Education: Launching awareness campaigns to educate residents about personal safety measures and reporting procedures, promoting community involvement and vigilance. 4. Collaborative Efforts: Fostering partnerships between law enforcement agencies, community organizations, and stakeholders to develop strategies for crime prevention, intervention, and rehabilitation. It's important to note the failure of previously attempted security measures as a need for reassessment and improvement in implementing these strategies.

As an example, moving vehicles for snow emergencies, street cleaning, etc are important things that citizens need to do to enable public works. On many streets, these are dictated by no-parking signs on a certain day. Often, public works does not execute the service, but the enforcement happens anyway. The fines are also not transparent, nor nominal. I believe that enforcement is important when it's required, but when services don't happen and residents are charged anyway, it appears as a money-grab from the city, and not a small one.

My neighbors burn recreational fires starting at 1am and going past 3am. I would like a fire curfew like Minneapolis, Maplewood, and North Saint Paul. Especially with the size of our city lots, the fires impact everyone and there's nothing we can currently do besides noise complain. I would like parity with our neighboring cities.

Our city's properties, empty lots, vacant buildings are not being kept up as they were a few years ago. Grass is so overgrown in areas onto sidewalks and gutters that rain water floods streets, trash is clogging storm drains- city mows their lots and does not pu trash, they mow right over and leave storm drains and gutters full of trash (and this also

causes people to continue to litter). Shotty upkeep is leading to safety issues to the public (empassable or dangerous sidewalks from protruding trees weeds, grass growing in the cement cracks and corner cement where people cross the street), drawing crime to these areas, attracting drug use, prostitution, rodents, garbage/trash dumping and lastly, it makes our city look like a glorified dump. When the city keeps things up, residents and business are much more likely to do suit. We've tried it in our neighborhood and it works. In addition, it cuts down on easy areas for criminal activity, thus cutting down on crime/drug use and police calls. There is clearly a bias towards certain areas of the city, like FROGTOWN. Just because lower income people reside there does not mean they don't deserve the same services other parts of the city receive. They have the right to safe city sidewalks/streets, clean city areas, etc. I see a lot of our services ignored or done shotty as compared to other parts of the city. And if we complain we are given the brush off or greatly rudely as if we are asking for the moon. We pay tax dollars just like everyone else-

I want to know that my tax dollars are being utilized to their fullest potential as well as see the city succeed and grow.

Ensure that city council meetings, decisions, and actions are transparent and accessible to the public.

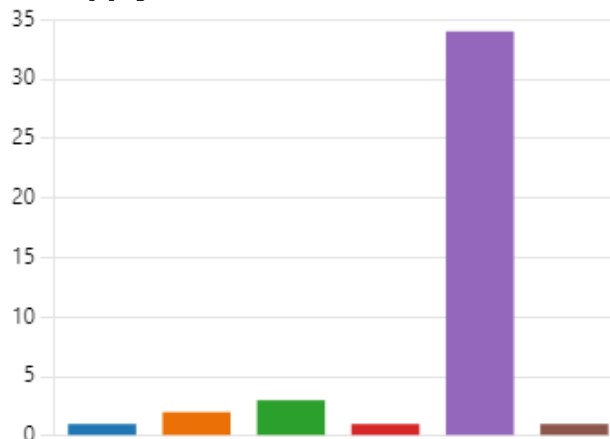
