Description of Variance:

Location: Summit near Nina to Selby and Summit- Selby to Kellogg at Cathedral Hill Park,

Noise Source: Team Ortho Foundation has requested a sound level variance to provide the use of a sound system for announcements, amplified sound and DJ at Summit near Nina to Selby and by Cathedral Hill Park, for the Monster Dash Pre Race Costume Contest and Race Announcements. The variance is requested for the hours of 8:00 a.m. until 9:00 a.m., with a pre-event sound check at 7:45 a.m. by Summit near Nina to Selby and from 7:30 a.m. until 8:30 a.m., with a pre-event sound check at 7:15 by the Cathedral Hill Park on Saturday, October 31, 2015. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 8:00 a.m. to 9:00 a.m., with a pre-event sound check at 7:45 a.m. for the Summit near Nina to Selby Area and from 7:30 a.m. until 8:30 a.m., with a pre-event sound check at 7:15 a.m. at the Cathedral Hill Park on Saturday, October 5, 2015. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 9:00 a.m. on the date of the event.
