Noise Source: Twin Cities in Motion has applied for a sound level variance in order to provide outdoor announcements, speakers and use of microphones at 75 Rev Dr Martin Luther King Boulevard, State Capitol Complex on Saturday, October 3, 2015, from 6:30 a.m. to 12:00 p.m., with a pre-event sound check from 6:15 a.m. until 6:30 a.m. and from 7:00 a.m. to 2:00 p.m., with a pre-event sound check from 6:45 a.m. until 7:00 a.m. on Sunday, October 4, 2015. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for the hours of 6:30 a.m. to 12:00 p.m., with a pre-event sound check from 6:15 a.m. until 6:30 a.m. on Saturday, October 3, 2015 and from 7:00 a.m. to 2:00 p.m., with a pre-event sound check from 6:45 a.m. until 7:00 a.m. on Sunday, October 4, 2015. 2) All electronically powered equipment used in conjunction with the event must not exceed 85 dBA as measured 50 feet from sound source. 3) The applicant will provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices will be turned off no later than 12:00 p.m. on Saturday, October 3, 2015 and no later than 2:00 p.m. on Sunday, October 4, 2015, the dates of the event.
