

KNOW ALL MEN BY THESE PRESENTS: That the State of Minnesota, by and through its Board of Trustees of the Minnesota State Colleges and Universities, a sovereign body, owner of the following described property situated in the City of Saint Paul, County of Ramsey, State of Minnesota:

TRACT 1:

Parcel 1:
