**RESOLUTION**

1 WHEREAS, adverse action was taken against the Auto Body Repair/Painting Shop license held by  
2 Perfect Auto Body, Inc. d/b/a Perfect Auto Body (License ID #20080000878) for the premises located at  
3 204 Bates Avenue in Saint Paul, by Notice of Violation dated August 20, 2010, alleging that during  
4 inspections on July 7, 2010 and again on August 4, 2010, an inspector from the Department of Safety and  
5 Inspection cited the licensee for numerous violations to license conditions, property not maintained in  
6 violation of § 45.03 (7) of the Nuisance Ordinance and outdoor storage kept longer than ten (10) days in  
7 violation of § 60.220 (S) and § 63.113 of Saint Paul Zoning code; and

9 WHEREAS, per Saint Paul Legislative Code §310.05 (m) (1), the licensing office recommended a  
10 \$500.00 matrix penalty and required compliance with license conditions within thirty (30) days. The  
11 licensing office also recommended the addition of the following license condition: "14. Grass and weeds  
12 on the property must be maintained in accordance with Saint Paul Legislative Code § 45.03 (7); and

14 WHEREAS, licensee did not respond to the Notice of Violation to pay the \$500.00 matrix penalty  
15 and call to arrange for a re-inspection within thirty (30) days to verify compliance or request a hearing; and

17 WHEREAS, the Notice of Violation stated that if the licensee failed to pay the \$500.00 matrix  
18 penalty, call to arrange for a re-inspection within thirty (30) days to verify compliance or request a hearing  
19 by September 20, 2010, that the matter would be placed on the consent agenda to impose the recommended  
20 penalty; now, therefore, be it

22 RESOLVED, that Perfect Auto Body, Inc. d/b/a Perfect Auto Body is hereby ordered to pay a  
23 matrix penalty of \$500.00 for the license condition, Nuisance Ordinance and St. Paul Zoning Code  
24 violations cited by a DSI Inspector during inspections on July 7, 2010 and August 4, 2010. Payment of  
25 such penalty shall be made within thirty days of the date of the adoption of this resolution.

27 FUTHER RESOLVED, the following will be added to their list of license conditions: "Grass and  
28 weeds on the property must be maintained in accordance with Saint Paul Legislative Code § 45.03 (7)."
