Mr. Laliberte,

The permit is required to be finaled because you pulled a single permit for the window and the roof.

The window was part of the correction orders, as well as the part of the roof line and fascia. Below are the items noted by inspector Wheeler in the revocation notice. While you were not required to replace the roof, the permit cannot be finaled until all the work on the permit is completed. Had you pulled a separate permit for the window, this would not have been an issue.

Secondly, pulling a permit does not mean you get a year to complete the work from our division. The deadlines from our office supersede the time limit before a permit expires.

Please get this permit finaled ASAP otherwise we will have may have to consider enforcement action.

Repair and maintain all exterior surfaces in a professional manner.
- 9. Upper unit Upper floor bedroom SPLC 34.09 (4), 34.33 (3) Repair and maintain the window glass. Upper unit, upper floor bedroom window has a hole in the window, glass cracking throughout the window **New window installed without permit. New windows required to be installed under permit.**
