Noise Source: Anderson Race Management has requested a sound level variance, at requested sound level limit of 90 dBA at no specified distance, to provide announcements and music at Harriet Island for the Chocoholic Frolic 5K/10K Run and Walk. The variance is requested for the hours of 9:00 a.m. to 1:00 p.m., with a pre-event sound check at 8:00 a.m. on Sunday, November 5, 2017. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 9:00 a.m. to 1:00 p.m., with a pre-event sound check at 8:00 a.m. for the Event on Sunday, November 1, 2017. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 1:00 p.m. on the date of the event.
