This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Location: 400 Snelling Ave. N. – Live music in the street and DJ Booth within the Beer Garden Area **Noise Source**: Zacharia Litzelswope, Director of Events and Guest Experiences for the MNUFC, has requested two sound level variances, at a requested sound level limit of 105 decibels (dBA), at no specified distance for the August 17, 2019 Game and 90 decibels (dBA) at no specified distance for the September 7, 2019 Game, to present amplified music within the street and DJ Booth area within the Beer Garden area for the pre-game of the Minnesota United FC vs Orlando City SC and MN United FC vs Pachuca Games. The variances are requested for the hours of 4:30 p.m. to 11:00 p.m., with a pre-event sound check at 3:30 p.m. on Saturday, August 17, 2019 and Saturday, September 7, 2019. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variances shall be for the hours of 4:30 p.m. to 11:00 p.m., with a pre-event sound check at 3:30 p.m. for the amplified music in the street and DJ Booth area within the Beer Garden area for the Minnesota United FC vs Orlando City SC and MN United FC vs Pachuca Games on Saturday, August 17, 2019 and Saturday, September 7, 2019. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA at 50 feet from any sound source.

3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 11:00 p.m. on the dates of the events.
