Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting has been scheduled for **Wednesday, May 1, 2013 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

Enclosed are copies of the resolution and supporting documents which will be presented to the City Council for their consideration. This is an uncontested matter concerning the fact that the licensed establishment purchased and possessed stolen merchandise, engaged in food stamp trafficking, possessed drug paraphernalia, allowed individuals to purchase narcotics on the premises, and sold single cigarettes, in violation of Saint Paul Legislative Code sections 310.06(b)(6) (a) and (c) and 310.06(b)(8).

Due to the seriousness and extent of these offenses, which are considered directly related to the license activity at the licensed establishment, per Saint Paul Legislative Code § 310.05 (m) (5) the licensing office will recommend revocation of all licenses held by Kadi Brothers, Inc. d/b/a Vas Market.




