In addition to the \$50,000 now being awarded to First Tee Learning Center through the Neighborhood STAR Year-Round Program, Resolution #10-1021 approved changing a \$150,000 loan awarded to the First Tee Learning Center through the 2009 Neighborhood STAR Program to a grant code making for a total 2009 grant award of \$300,000. Finally, five (5) previously funded Neighborhood STAR Year-Round Program projects have be completed under budget with the remaining balances now being moved from project specific codes to the Neighborhood STAR Year-Round Program code.
