The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance will be for the hours from 11:00 a.m. until 10:00 p.m. on Friday, June 17, 2015 and from 10:00 a.m. until 10:00 p.m. on Saturday, June 18, 2015 for the Outdoor Event to be held at Harriet Island 2) All electronically powered equipment used in conjunction with the event must not exceed 100 dBA at the sound mix or 100 feet from stage, whichever is the shorter distance. 3) The applicant will provide personnel and equipment to ensure compliance with these conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices must be turned off no later than 10:00 p.m. on the event dates.
