Councilmember Bostrom asked for a one week layover to get a staff report. Council President Stark said it was his understanding that there was already a license for the operator of the golf course which was essentially across the street and this was essentially using the same license. Councilmember Thune said he didn't think it was anything to worry about. Councilmember Bostrom said he was just looking for a little explanation as to how it worked. Councilmember Thune said it was like the golf courses or the ballpark, and the expansion outdoors was like with anyone else. He said he didn't think the Council should hold it over. Councilmember Bostrom said he wouldn't request a layover but asked for a report from staff on how it worked for City liquor license to cover a private business. He moved approval of the resolution.*
