Hello Mr. Hamblin,

This is to confirm that on February 7, 2017 at the Legislative Hearing, Marcia Moermond, recommended that the City Council grant additional extensions as follows:

- 1) grant to February 17, 2017 for the removal of the closed door(s) related items (fridge, freezer), tires, tarps, stove, and other hazardous materials;
- 2) grant to April 1, 2017 to reduce the volume (as measured on February 17, 2017) of the excessive accumulation in half; and 3) grant to June 1, 2017 for the abatement of the remaining items.

If you wish to appeal to this recommendation of extensions, you may attend the City Council Public Hearing on Wednesday, February 15, 2017 at 5:30 p.m. in Room 300 Council Chambers.
