NOTICE OF PUBLIC HEARING

Sound Level Variance – Fiestas en La Placita Friday Music Series – May 5 and September 15, 2017

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance

Location: Events will be located outdoors at the La Placita patio space, 193 Cesar Chavez Street

Noise Source: El Burrito Mercado, Milissa Diaz, President/Owner, has applied for a sound level variance, at a requested sound level of 80 dBA at no specified distance in order to provide live or recorded music outdoors at the La Placita patio space at 193 Cesar Chavez Street on Friday, May 5, 2017 and Friday, September 15, 2017 for the Fridays Music Series, Fiestas en La Placita. The Department of Safety and Inspections recommends the following conditions: 1) Variance will be for live or recorded music from 5:00 p.m. to 8:00 p.m. on Friday, May 5, 2017 and 6:00 to 9:00 p.m. on Friday, September 15, 2017. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 80 dBA, as measured at 50 feet from the noise source. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 8:00 p.m. on Friday, May 5, 2017 and no later than 9:00 p.m. on Friday, September 15, 2017.
