**Noise Source:** Minnesota Public Radio Live Radio Broadcast of A Prairie Home Companion, represented by Thomas Campbell, Manager, Stage Productions, has requested a sound level variance in order to present outdoor music concerts at the Main lawn of Macalester College by the Chapel and Student Center at 1600 Grand Avenue. Rehearsal is scheduled from 10:00 a.m. until 5:00 p.m. on Friday, July 3, 2015, and Performance is scheduled from 10:00 a.m. to 10:00 p.m. on Saturday, July 4, 2015. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The variance shall be for the hours of 10:00 a.m. to 5:00 p.m. on Friday, July 3, 2015 for a Rehearsal date; and from 10:00 a.m. to 10:00 p.m. on Saturday, July 4, 2015 for Performance. 2. All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 5:00 p.m. on July 3, 2015 for the Rehearsal date, no later than 10:00 p.m. on July 4, 2015, the Performance date.
