Saturday, June 21, from 1:00 PM – 4:30 PM

We are thrilled to partner with the Twin Cities Jazz Festival to present what we hope will become an annual tradition: the River Stage. This unique riverside music experience will be featured as an official part of the Twin Cities Jazz Festival, scheduled for June 20–21. Jazz Fest will announce the complete festival lineup on April 30 and include the announcement of our River Stage at that time. The event also will be included in all official Jazz Fest promotions—on their website, social media, and during the event itself.

Event #2: 80 Days Around St. Paul Parks Wrap-up Party in Partnership with Saint Paul Parks Conservancy

Sunday, August 3, from 1:00 PM – 4:00 PM

Our second event is in partnership with the Saint Paul Parks Conservancy as part of their “80 Days Around the Parks” initiative. To help wrap up their summer-long effort encouraging visitation to Saint Paul's parks, we will co-host a celebratory event featuring live music on the river. This collaboration aims to shine a spotlight on our river parks—Upper Landing, Raspberry Island, and Harriet Island—and create a vibrant, family-friendly finale to the summer.

- (1) 10x10' pop-up tent 50 feet away from stage, with Front of House 32-channel soundboard

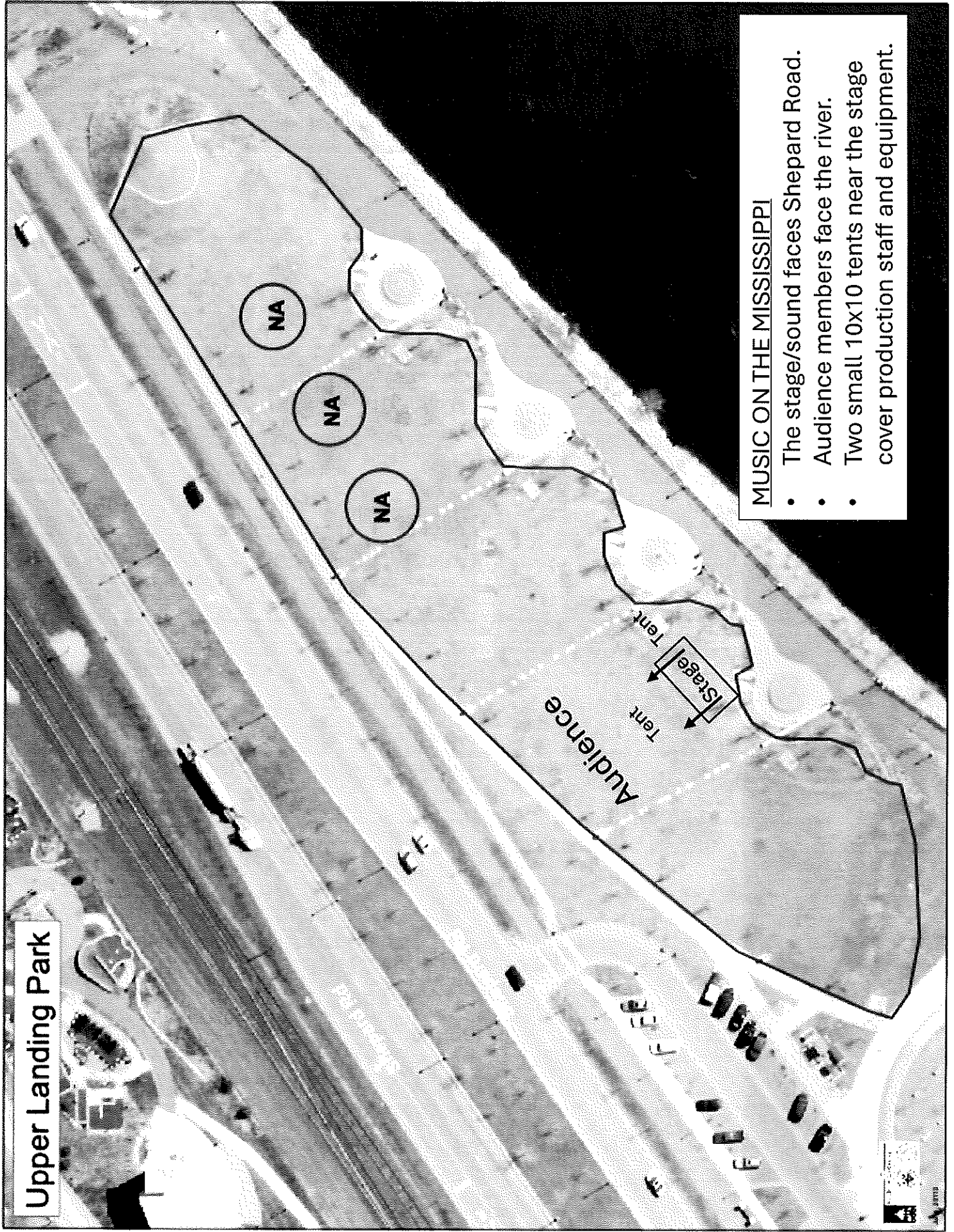
We are excited to bring people to the river this summer and to collaborate with dedicated St. Paul partners. We appreciate your support of our request for these two summer dates.

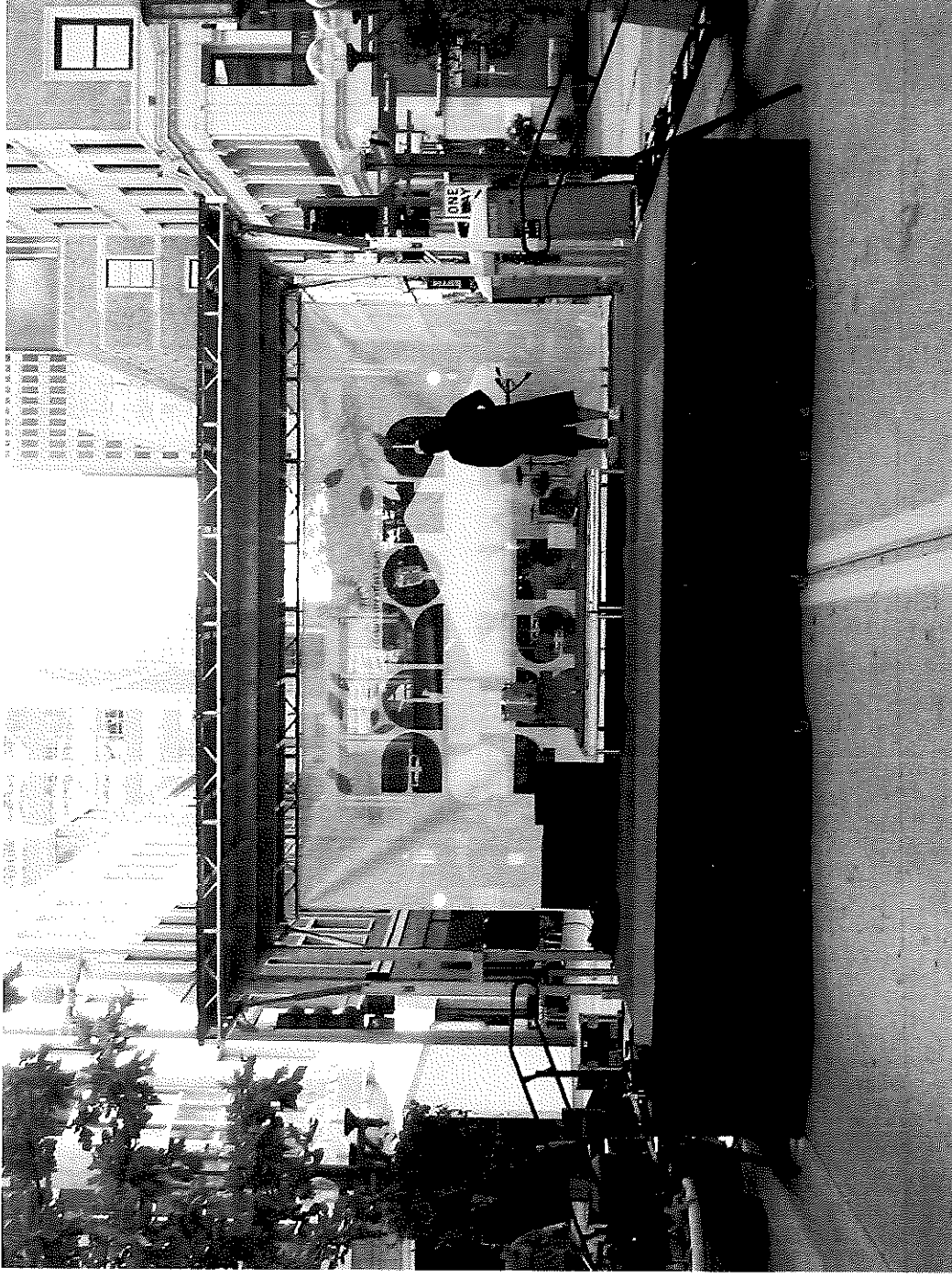
